- acknowledge that the *Income Tax Act*, RSC 1985, c.1, requires the BRMB to prepare a Statement of Farm Support Payments (AGR-1) and report the Tax Reporting Number on the AGR-1 for any Payments made under this Program; and
- without limiting the generality of section 9.5 of the Program Terms and Condition, consent to the BRMB disclosing all personal information that I/the applicant provides to the BRMB and the BRMB collects about me/ the applicant to other provincial or federal government ministries or municipal governments that are offering any assistance whatsoever as a result of the wildfire for the purpose of verifying the information provided and for the purpose of coordinating the assistance provided.
