- 8 Does not include those crop areas suppressed to meet the confidentiality requirements of the Statistics Act.
- 9 The "number of farms reporting" may not equal the sum of the parts because farms reporting more than one category (or activity) are only counted once. A new conceptual definition of a "farm" was introduced in 2021 so historical comparisons are not recommended.
