# **BRITISH COLUMBIA BUILDING CODE ORDER**

**1** Book 1 (General) of the British Columbia Building Code established by the British Columbia Building Code Regulation, Ministerial Order No. BA 2023 10, is amended as set out in this Schedule.

### DEFINITION OF A COORDINATING REGISTERED PROFESSIONAL

2 Sentence 1.4.1.2.(1) of Division A is amended by adding the following definition:

*Coordinating registered professional* means a *registered professional* retained under Clause 2.2.7.2.(1)(a) of Division C to coordinate all design work and *field reviews* of the *registered professionals* who are required for a project.

### NUMBERING CHANGES TO SENTENCE 6.2.1.5.(1) OF DIVISION B

**3** Sentence 6.2.1.5.(1) of Division B is repealed and the following substituted:

e) CSA B365, "Installation Code for Solid-Fuel-Burning Appliances and Equipment," or
f) a combination thereof.

**4** Sentence 9.33.5.2.(1) of Division B is repealed and the following substituted:

**1**) Except as provided in Articles 9.33.5.3. and 9.33.5.4., the installation of heating and air-conditioning equipment, including mechanical refrigeration equipment, and including provisions for mounting, clearances and air supply, shall conform to

a) the Safety Standards Act and pursuant regulations,
b) reserved,
c) CSA B139 Series, "Installation code for oil-burning equipment,"
d) reserved,
e) reserved,
f) CAN/CSA-C448 Series, "Design and installation of earth energy systems," or
g) a combination thereof.
