

Exemption Report for 2023

British Columbia Renewable and Low Carbon Fuel Requirements Regulation

It is the responsibility of anyone who manufactures or imports fuel to determine whether their activities qualify them as a Part 2 (Renewable) and/or Part 3 (Low Carbon) fuel supplier under the *Greenhouse Gas Reduction (Renewable and Low Carbon Fuel Requirements) Act* (available online at www.bclaws.ca).

The 2023 compliance period for Part 2 and Part 3 requirements is from January 1 to December 31, 2023. **Exemption Reports for 2023 are due Sunday, March 31, 2024.**

Should I complete an "Exemption Report for 2023"?

Fuel suppliers and their affiliates who supplied less than a total of 200,000 litres of gasoline and diesel class fuels (combined) in the 2023 compliance period may apply to be exempted from Part 2 and/or Part 3 requirements. A Part 2 or Part 3 fuel supplier who applies to be exempted must submit an Exemption Report, available from www.gov.bc.ca/lowcarbonfuels. A Part 3 fuel supplier who does not supply any Part 2 fuels may not be exempted.

Affiliated Companies

For companies with affiliated companies who are also Part 3 fuel suppliers in B.C., please include the legal name and addresses of those affiliates and the volume of Part 2 fuel supplied by each of those affiliates in B.C. in the 2023 compliance period. Company names entered in the business information section will be automatically entered into the fuel supply volume section.

Instructions

The quantity of fuel supplied in the compliance period is the total volume of Part 2 fuel that was imported, manufactured, or acquired by all affiliated companies under an agreement described in section 6 of the Renewable and Low Carbon Fuel Requirements Regulation (Regulation), and then sold or used. Fuel exported from British Columbia is not included.

As a fuel supplier you must report the total volume that you supply, even if it is zero. All volumes are to be reported in litres.

Line 1	Report the total volume of gasoline class fuel supplied by each company listed in the compliance period. This is the sum of all gasoline class fuel that was imported, manufactured, or acquired under an agreement described in section 6 of the Regulation, and then sold or used. Do not include any volumes exported from British Columbia.
Line 2	Report the total volume of diesel class fuel supplied by each company listed in the compliance period. This is the sum of all diesel class fuel that was imported, manufactured, or acquired under an agreement described in section 6 of the Regulation, and then sold or used. Do not include any volumes exported from British Columbia.
Line 3	Report the total volume of gasoline and diesel class fuel supplied in the compliance period. The total for all affiliated companies must be less than 200,000 litres in order to apply for exemption. This calculation is done automatically in the form; please verify that the value is correct.
