# **Exemption Report for 2024**

Low Carbon Fuels Act

It is the responsibility of anyone who manufactures or imports fuel to determine whether their activities qualify them as a fuel supplier under the Low Carbon Fuels Act (Act) (available online at www.bclaws.ca).

The 2024 compliance period for requirements is from January 1 to December 31, 2024. Exemption Reports for 2024 are due Monday, March 31, 2025.

### Should I complete an "Exemption Report for 2024"?

Fuel suppliers or marketers and their affiliates who supplied less than a total of 200,000 litres of gasoline and diesel category fuels (combined) in the 2024 compliance period may apply to be exempted from the renewable and low carbon fuel targets. A fuel supplier/marketer who applies to be exempted must submit an Exemption Report, available from www.gov.bc.ca/lowcarbonfuels. A fuel supplier who does not supply any fuels may not be exempted.

### Affiliated Companies

For companies with affiliated companies who are also fuel suppliers in B.C., please include the legal name and addresses of those affiliates and the volume of fuel supplied or marketed by each of those affiliates in B.C. in the 2024 compliance period.

Jet Fuel

Beginning in 2024, jet fuel is covered under the Act. Suppliers/marketers of jet fuel may apply for exemption from the renewable and/or low carbon fuel requirements for volumes not exceeding 100 million litres. Unlike gasoline and diesel category fuels, jet fuel can be exempted even if the combination of jet fuel and other fuels exceeds 100 million litres provided that the supply of jet fuel does not exceed 100 million litres. Reporting of jet fuel is completed through the LCFS Portal, *not* on this form. If you supply jet fuel please contact lcfs@gov.bc.ca for access to the Portal for reporting.

### Instructions

The quantity of gasoline and diesel category fuels supplied or marketed in the compliance period is the total volume of fuel that was imported, manufactured, or acquired by all affiliated companies under an agreement described in section 7 of the Act, and then sold or used.

Line 1	Report the total volume of gasoline category fuel supplied by each company listed in the compliance period. This is the sum of all gasoline category fuel that was imported, manufactured, or acquired under an agreement described in section 7 of the Act, and then sold or used.					
Line 2	Report the total volume of diesel category fuel supplied by each company listed in the compliance period. This is the sum of all diesel category fuel that was imported, manufactured, or acquired under an agreement described in section 7 of the Act, and then sold or used.					
Line 3	Report the total volume of gasoline and diesel category fuels supplied in the compliance period. The total for all affiliated companies must be less than 200,000 litres in order to apply for exemption.
