Background

B.C.'s Low Carbon Fuel Standard (LCFS) sets requirements that encourage the use of renewable and low carbon fuels and offers incentives to organizations that supply them. Organizations generate positive compliance units (credits) for supplying fuels with lower carbon intensity and incur negative compliance units (debits) for supplying fuels with higher carbon intensity, as outlined in Section 13 of the [B.C.'s Low Carbon Fuels Act \(Act\)](#).

The LCFS credit market is the central mechanism under the Act that enables the exchange of credits generated through fuels supplied for applicable purposes. The credit market helps organizations meet their compliance obligations and support the overall goal of reducing greenhouse gas emissions in the transportation sector.

The [Low Carbon Fuels \(General\) Regulation](#) (LCFGR) establishes a framework for market participants who do not have a compliance obligation– such as brokers or traders – to engage in the credit market. These organizations must be registered by the Director in accordance with Section 17 of the LCFGR to participate in the credit market. The Director has discretionary authority to refuse, suspend or cancel an organization's registration.

Credits issued by the director

Before credits can be transferred, they must be issued by the director. Credits may be issued under the following circumstance:

- Submission of an annual compliance report. The director will issue credits based on verified data from the report.
- Achievement of a milestone under an initiative agreement. Credits are valid immediately upon issuance by the Director.

Only after issuance can credits be used or transferred within the credit market.

Fair market value

All transfers must include a "fair market value" of the consideration in Canadian dollars per credit, under section 18 of the LCFGR. Transfers that the director considers are underestimating "fair market value" or those using a "zero dollar" value must include a written explanation justifying the use of the identified value.

The "fair market value" is generally accepted as the dollar figure a credit would sell for on the open and unrestricted market, between a willing buyer and a willing seller who are both knowledgeable, informed, and prudent, and who are acting independently of each other.

Approval of transfers

All transfers must be approved by the director. A registered organization may submit a transfer for review through the LCFS Portal. The transfer will take effect on the date on which the transfer is approved by the director.

Application of credits

Only those credits held on the reporting deadline can be applied to a compliance obligation for that compliance period. Credits cannot be retroactively applied for compliance obligations of previous compliance years.

Allocation agreements

Allocation agreements allow fuel suppliers to transfer reporting responsibilities to another organization, enabling participation in the credit market for small suppliers who fall below reporting thresholds. This agreement assigns the reporting and credit-earning responsibilities to another organization. For more information on allocation agreements see [Information Bulletin RLCF-015](#).
