Evaluating Forest Management in British Columbia

The Forest and Range Evaluation Program (FREP) was established in 2003 by the Ministry of Forests and Range (MOFR) and the Ministry of Environment (MOE).

The FREP Mission:

To ensure British Columbia is a world leader in sustainable forest management by providing the high quality, science-based information we need for decision-making and continuous improvement of our forest practices, policies and legislation.

The purpose of the Forest and Range Evaluation Program is to determine whether forest and range practices in British Columbia are achieving government's objectives for the resource values identified in the Forest and Range Practices Act (FRPA).

The specific objectives of FREP are to:

- Evaluate the status or trends of resource values and determine the causal factors;
- Determine whether resource values are being managed in a sustainable manner through proven or alternative forest practices; and,
- Recommend changes to forest and range practices, policies and legislation, where required.

To achieve these objectives, FREP internal and external partners will be asked to:

- Identify, prioritize and re-assess evaluation questions that need addressing;
- Develop measurable, cost-effective indicators, methodologies, and quality assurance protocols for testing evaluation questions;
- Evaluate priority questions through intensive, extensive and routine evaluations;
- Communicate the results of evaluations; and,
- Develop recommendations for changes to forest practices, legislation and policy, for consideration by the FRPA Joint Management Committee (JMC) and the Program Sponsor (Chief Forester).

Setting Evaluation Priorities -- Overview

FREP identifies the need for, prioritizes and conducts timely, scientifically valid evaluations and monitoring. The process for determining which evaluation and monitoring initiatives are highest priority, and therefore a priority for funding, is laid out in this document.

FREP Priority Evaluation and Monitoring Questions

Identification of priority evaluation and monitoring questions regarding the evaluation of British Columbia's natural resource values is the foundation for allocating FREP resources. The priority evaluation questions (see example below) form the basis for developing appropriate resource stewardship monitoring indicators and protocols used to evaluate the status, trends and sustainability of BC's Forest & Range resource values. The questions are also used to identify important intensive evaluation projects. An example question from the 2004/05 questions, for the Riparian/Fish value is:

Are riparian forestry and range practices effective in maintaining the structural integrity and proper functioning of stream ecosystems and other aquatic resource features over both the short and long term?

Each year, the FREP Priority Evaluation Questions will be updated based on the steps detailed in Table A.

⁵SMART Principles for FREP Evaluation Questions

- Is the question specific (i.e., focused, bound, tied to specific deliverables, and have forest management applications)?
- Is the question measurable (i.e., tied to specific deliverables, with measurable indicators)?
- Is the question agreed to (i.e., internal and external stakeholder involvement, links to corporate performance measures)?
- Is the question realistic (cost and funding, available expertise, timeframe)?
- Is the question time bound, or can it be made time bound (i.e., start and end dates for completion of all deliverables)?

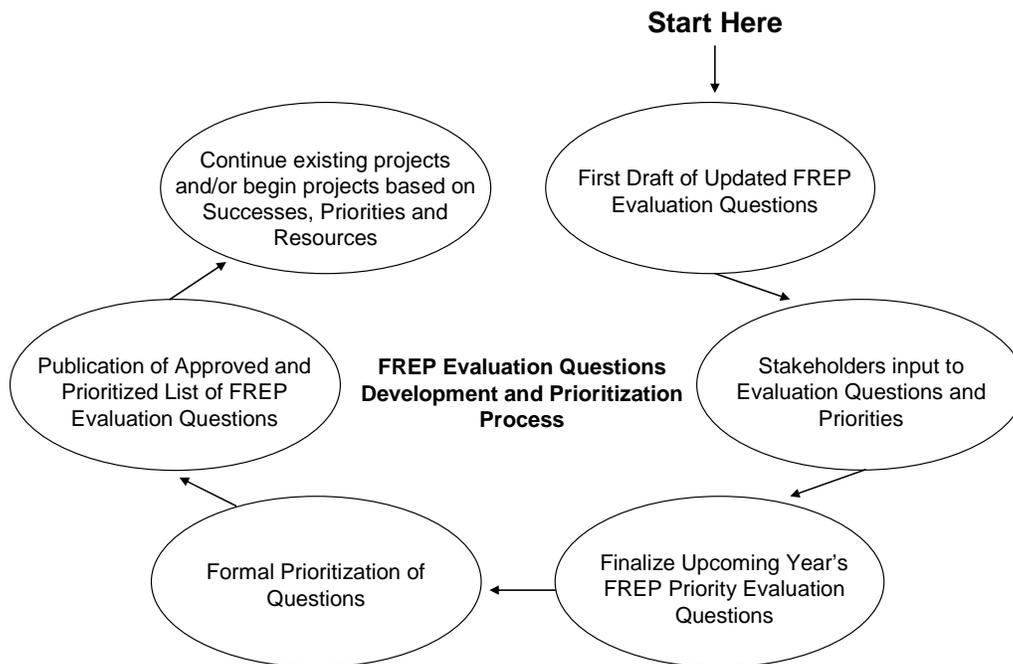


Figure 1: FREP Evaluation Questions Development and Prioritization Process

Table B: FREWG Considerations for Ranking of the Resource Evaluation Questions

A	Question supports continuation of existing successful initiative (40 points)
B	Compatibility with government priorities (maximum 20 points)
	1. Link to Service Plans and Regional priorities
	2. Area(s) of highest public concern
	3. Likely to lead to FRPA improvements
C	Benefits to FREP (maximum 20 points)
	1. Quick successes and deliverables, and/or ongoing initiative
	2. Opportunity for multi-value indicators and/or evaluations
	3. Improved partnerships and/or external linkages
D	Risks to delivery (maximum 20 points)
	1. Available expertise
	2. Stakeholder support
	3. Cost

Step 1. Upon submission of evaluation questions for all eleven resource values, all questions will be entered into a spreadsheet ranking template (Table B). This spreadsheet will be sent out to all members of FREWG asking them to complete the ranking.

Step 2. Data from all completed templates from FREWG members will be summarized into two summary tables: Table 1 -- the highest priority question per resource value and Table 2 -- the top 10 priority questions overall regardless of resource value.
