Accept the Site from the District Random List

- Follow protocol rules on accepting and rejecting from the random list.
- Starting at the top and working down; select Site Details link to document acceptance or rejection.
- Once Site Details have been saved, the selected checklist can be opened by clicking the Yes in the **Existing Checklists** column.
- Features on this page that help with site selection:
 - Map – if underlined, there is spatial information that can be viewed directly to the opening in mapview
 - Opening ID and Licence provide direct access to RESULTS and FTA.

View the Checklist

Checklists are generated when you accept a site for evaluation. There are two ways to view the checklist

- From the Accepted Sites List:** As you select sites from the District Random List, you build your Accepted Sites list. You can use this page to quickly find selected sites and display the associated checklists. There are a number of planning features available on this page; for example, you can also use the [District Map View](#) button to help plan site visits by displaying all selected sites on a map of your district.
- From the District Random List:** In the **Existing Checklists** column, you will see a Yes link in any row where a checklist has been generated. Click the Yes link for the correct site. You will see the name of the resource value as a link in the row you just selected, just below the Yes. Click the correct resource value link. The electronic checklist for the correct resource value opens.

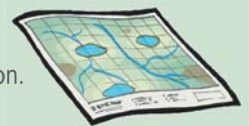

Complete the Screens which Correspond to your Paper Field Cards

- Administration** - Always fill this in first, particularly the **Evaluation Date** and **Team Lead** as this information is needed in other screens
- Opening** - Core descriptive information about the Opening is provided in this screen. The Gross Area Value is taken from RESULTS. Note that a FREP WTP Override field is available next to the Gross Area – this is used ONLY when the Gross Area from RESULTS does not incorporate WTPs, as identified in your documentation or your field work – thus the number you enter in the WTP Override field must be greater than the RESULTS gross area.
- Stratum Summary** - Document each stratum before entering plots in the Plot screen. When you save a stratum, a "tab" appears with the stratum name. Add additional stata using the **Add New Stratum** button.
- Plots** - Once the stata information has been entered you can document the associated plots. Select the appropriate **Stratum ID** and fill in the plot information from your plot field cards.
- Notes** - Document any further comments you may have. This section is optional, there is a 2000 character limit (reasonably sized paragraph). You will not get a warning if you go over the limit until you save.
- Attachments** - Attach a scanned map or key photographs and any other pertinent documentation. Remember pictures and drawings can be very helpful to others to understand the results of a field evaluation.



The size displays automatically when the file is attached. There is a 4mb size limitation.



Remember to read the help page for each screen, this provides field-specific assistance as well as tips on navigating around the screen and hints on how to enter data.

Correct Data

- As you complete and save each page, correct the data as directed by the error messages that display. Remember these edit checks are intended to help ensure data integrity.

Ensuring Data Quality:

The checklists in FREP IMS are designed to enforce the data collection and documentation standards outlined in the resource value protocols. When you save a screen or submit the checklist the system checks to make sure the data entered is valid. Please see the online help for a screen-by-screen summary of data quality rules that apply to Stand Level Biodiversity data.

Remember the difference between an error (a problem with the data, that only you can solve by modifying your data) and a bug (a problem with the system, these must be reported to the Help Desk immediately).

Submit your Checklist

- Once you have completed all the required screens, click the [Submit](#) button at the top of any of the screens in the checklist.
- Correct any problems and click the submit button again. A Submission Successful message displays when the process is finished and an [UnSubmit](#) Button becomes visible. Submitted checklists display on the **Accepted Sites** page highlighted in green.



If you submit a checklist in error, a system administrator can "unsubmit".
