How to Use LEXIS for the MFPR Exemptions and Permits

What you need to know before you begin ...

Currently, the Log Exemption Information System (LEXIS) is the online application being used to generate exemptions and permits under the Manufactured Forest Product Regulations (MFPR). However, LEXIS was designed for exemption for and permitting of logs but the desired result of creating exemptions and permits for manufactured timber is the same, so we are adapting LEXIS for MFPR use. The adaptations include not putting 'applications for exemptions' through the surplus test by advertising the applications and using only specific timber marks for each level of manufacturing within each region.

The various levels of manufacturing will be represented as 'timber marks' in LEXIS, as follows:

- COAST regions:
 - TAZELL – 0 processes, cedar and cypress species @ 100% fee in lieu
 - TAZEMM – 1 process, cedar and cypress species @ 2/3 fee in lieu
 - TAZENN – 2 processes, cedar and cypress species @ 1/3 fee in lieu
 - TAZEPP – all species except cedar and cypress and lumber greater than 0.1m² @ \$1.00/m³
- SOUTHERN INTERIOR regions:
 - TAZFBB – 0 processes, cedar and cypress species @ 100% fee in lieu
 - TAZFGG – 1 process, cedar and cypress species @ 2/3 fee in lieu
 - TAZFNN – 2 processes, cedar and cypress species @ 1/3 fee in lieu
 - TAZFZZ – all species except cedar and cypress and lumber greater than 0.1 m² @ \$1.00/m³
- NORTHERN INTERIOR regions:
 - TAZGBB – 0 processes, cedar and cypress species @ 100% fee in lieu
 - TAZGNN – 1 process, cedar and cypress species @ 2/3 fee in lieu
 - TAZGZZ – 2 processes, cedar and cypress species @ 1/3 fee in lieu
 - TAZGFF – all species except cedar and cypress and lumber greater than 0.1 m² @ \$1.00/m³

For the purposes of the MFPR, please only use 'Grade Z' for all species, regardless of level of manufacturing and region. For species list, see [Code List for Species in LEXIS](#).

Obtaining Access to LEXIS

To enter your exemption applications and permits on-line into the Log Exemption Information System (LEXIS), you must be granted access to LEXIS.

To gain access, email the following information to Provincial.Log.Export.Analyst@gov.bc.ca:

1. **The BCeID used to login to LEXIS.** Some industry users will already have a Business BCeID for use with other ministry on-line applications such as HBS, RESULTS or ECAS in which case you can also use it for LEXIS. If not, you can search for your company [within the BCeID Online Business Directory](#). Then, contact the Profile or Account Manager listed for your company to request access. If your company is not found, [follow the registration process to obtain a Business BCeID](#). More info available at www.bceid.ca.

2. **The name, email address and telephone number**, to confirm the correct BCeID.
3. **The company name and ministry client number for the company to be linked to the BCeID.** Some applicants will already have a client number, in which case it can also be used for LEXIS. Client numbers are up to 8 digits long. If you are unsure about this, please contact Provincial.Log.Export.Analyst@gov.bc.ca to confirm.

Once the above information is processed you will receive an email notice confirming your access to LEXIS is active.

Note that if you are a company acting on behalf of the manufacturing mill (i.e., the Agent), then you will also require a BCeID that must then be linked to the mill company's BCeID (i.e., the Owner). Linking your BCeID to the mill company's BCeID business account can be accomplished by the mill company's BCeID Application Manager.

Introduction to the MFPR Exemption and Permitting Process

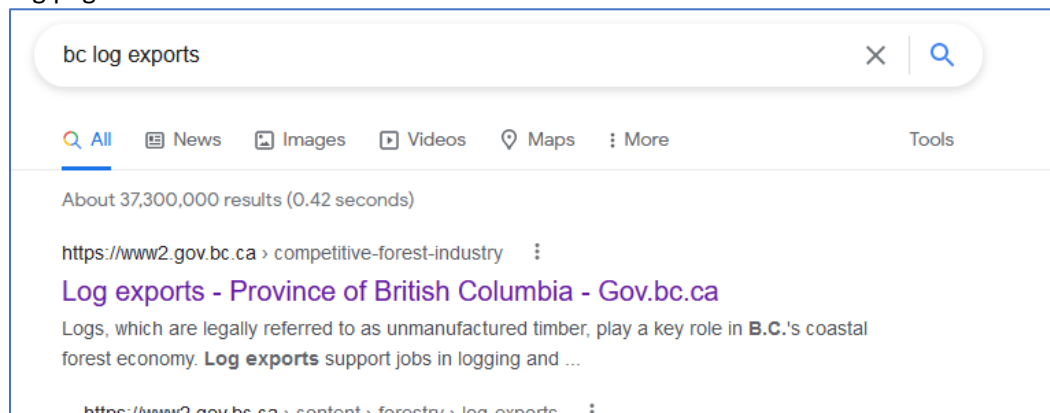
The export permit we use to track the level of manufacturing and species of lumber covered by the Manufactured Forest Products Regulation (MFPR) must be tied to an approved exemption. Exemption volumes must be applied for in LEXIS, this is called an ‘application for exemption.’ An approved exemption is valid for six months. Exemptions are approved on behalf of the Minister of Forests by senior management. After a ministerial exemption is approved, the client may request a permit to export the lumber against that exemption, provided all the necessary details are supplied. Permits are then reviewed and issued by staff, who also prepare the corresponding invoice for any Fee in Lieu of Manufacturing owed to the government. The invoices are tracked by the Ministry of Finance, and all payments are made to them. All invoices related to a permit will be listed on the GBMS tab of the permit.

Login to the Log Exemption Information System (LEXIS)

To begin, **login** with your BCeID to LEXIS using either:

- Companies applying for a permit will be required to submit a declaration ([FS 1491 \(PDF, 131KB\)](#)) that confirms the processes applied to the lumber, the volume and total value of the shipments. In addition, companies will be required to submit an annual report ([FS 1492 \(PDF, 141KB\)](#)) that may be used for reconciliation and audit purposes

Method to Use for MFPR Exemptions and Permits

Some clients only periodically export volumes of unmanufactured timber and other clients process several shipments in a week. While the overall process remains the same regardless of the number of shipments or the volume quantities, there is a process for frequent shipments/permits against one larger exemption.

Create the EXEMPTION APPLICATION

- **Location of Logs**, mandatory: Use address of manufacturing plant
- **Age Class**, mandatory: Old Growth is the default, Second Growth is the option on dropdown
- **Average Log Volume**, mandatory: Please enter **1.0 m³** (to 1 decimal place)
- **Application Volume**, mandatory: Enter **total volume** (in cubic metres to 1 decimal place) for all species. Conversion is 1MMBF = 2360 m³. Maximum application volume is 15,000 m³.
Note that if this exemption is to cover only one shipment, then the Application Volume should be for that volume. If this exemption is to cover many shipments over the 6-month exemption period, then the volume should be an estimated volume (up to a maximum of 15,000 m³).
- **Species List**, mandatory: Select from dropdown list (see [Species Code List](#))
- **End Use**, mandatory: Select only “**Sawlog**” from the dropdown

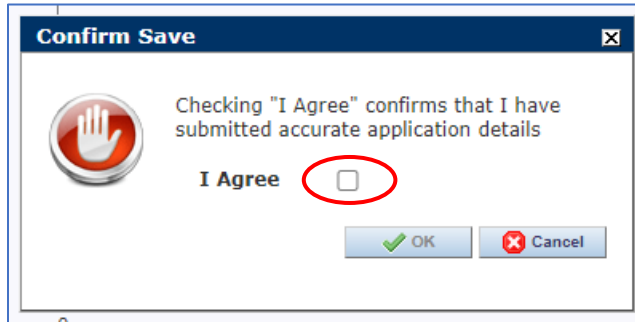

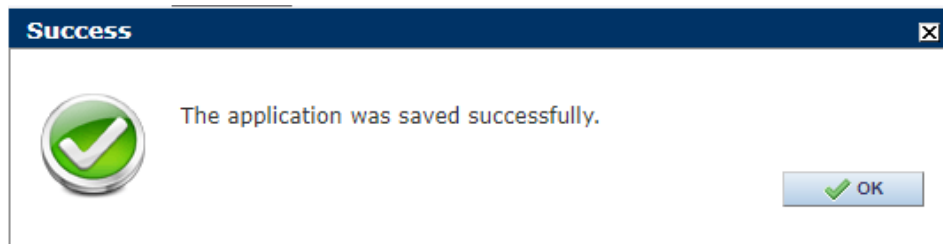
Save the application by selecting the  in the bottom right-hand corner. You are required to save the application at this point and will get an error if you do not. Saving will generate a system-generated application number, shown at the bottom.

A small window will open asking you for confirmation:



Select the box beside 'I Agree' then the  button will be available to select and close the window.

You will then get a confirmation of the Save in a new window, or an error if something is missing/wrong. **Close** by selecting OK button:



When that window closes the application will refresh with an assigned Application Number. The number will now display in the bottom left corner of the page:

For permits to be created after an Application for Exemption has been approved, the specifics of your shipments must be detailed by groups that are called 'Packages' in LEXIS. The Package must be part of the application before it can be attached to a request for a permit.

For a single shipment and when the details are known, you can enter the detailed package information on the Items tab at this time. To continue adding package information now, go to section: [Add PACKAGE Information to Application](#).

If you are requesting an exemption to cover many shipments over 6 months and will add the individual packages later when a permit is required, you can proceed to section: [Submit EXEMPTION Request](#).

Add PACKAGE Information to Application

Background Information:


Each application must include a description of the unmanufactured lumber by package in LEXIS. Each 'package' requires a unique label for identification of that group of lumber and the label/name is determined by the applicant.

Each Package must have a Summary of Scale attached to it where each line of scale represents a level of manufacturing per species. You cannot enter more than one line for each combination of level of manufacturing and species, where level of manufacturing is represented by a different timber mark.

Please refer to the first page of this document ([What you need to know before you begin ...](#)) for the levels of manufacturing and the corresponding timber marks and grades designated to utilize for MFPR shipments.

Select the Items tab of your new Application

LEXIS will add up the volume and pieces listed in all lines of scale for the package and display it as Total Scale Volume and Total Pieces for the Package.

If a mistake is made on any line, this can be corrected by deleting the incorrect line and replacing it with a new line with the correct information.

To delete a line, select the red 'X' icon in the delete column to delete that line, then re-select the *Add Item* icon to add the corrected information. Do this for each incorrect line.

Once again, double-check the totals at the top match when finished.


If you are adding a package to complete an application for a permit, you may now return to your newly created Permit number to add the application number to the permit. See section ['Create and Submit Request for PERMIT'](#) to finish the application.

Submit EXEMPTION Request

When you are satisfied all the information is included and accurate, you will need to notify the office that your exemption application is ready for review/approval. You will not be prompted for this step in LEXIS.

IMPORTANT

Notify LogExportPolicy@gov.bc.ca that you have submitted a request(s), including Application number(s) via email. Your notification will signal an exemption needs to be created and approved.

Exit the application for exemption by selecting the  button in the bottom right corner or select Logout from the LEXIS Menu on the left-hand side.

You will be notified by email once your exemption has been approved. From there, you will be ready to apply for the permit(s). See next section: [Create and Submit Request for PERMIT](#).

Create and Submit Request for PERMIT

After the Exemption is approved, applicants will receive a notification by email to confirm the approval and can now apply for a permit against that Exemption Number.

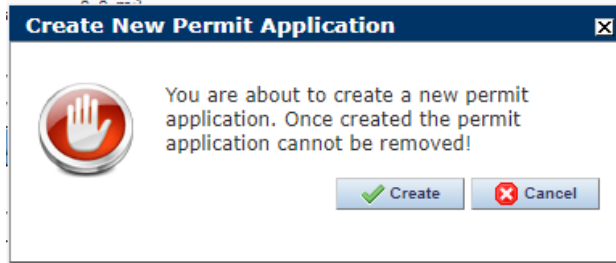



Each new Permit will have 6 tabs –

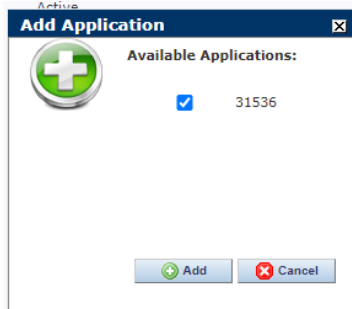

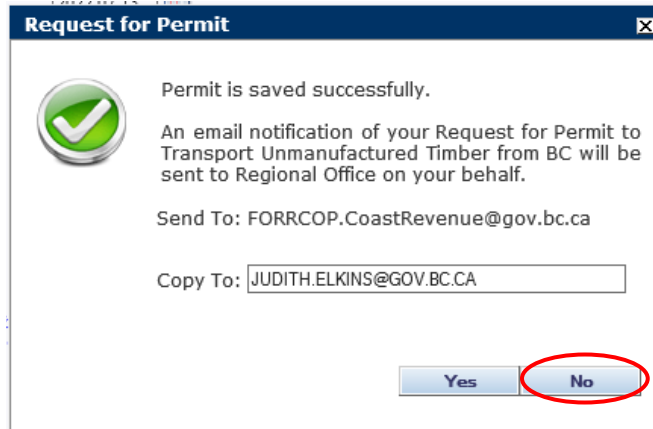
Save the permit request when you are satisfied all the information has been added and is accurate. If no shipping info was included, an error message will display to remind you. Selecting the OK button will close the error window and the permit will be saved without it.



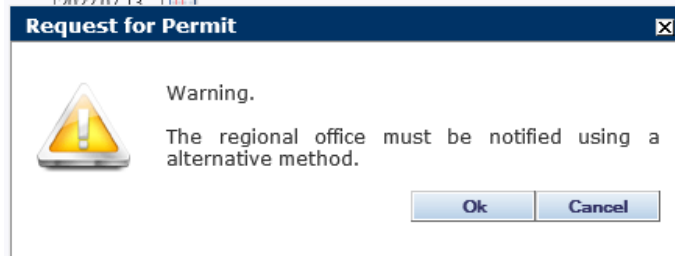
If there is no application attached, or if the attached application has no package and scale information, only the save will be acknowledged with a confirmation message window.



However, if both shipping information and an application has been attached, a new window will open to confirm the save and indicate the system is ready to send an email to the regional office. However, as the notifications were set up to notify the regional export office for log exports, this is not the office that processes MFPR permit requests, please **cancel the email notification** from being sent by selecting the 'No' button.



Selecting the No button will close the window and another small window will open reminding you that the office must be advised outside of LEXIS.



Close the warning message window by selecting the OK button. To exit the Permit, select the Cancel button in the bottom right corner.
