Re: Interim Guidance for Commercial Thinning – Interior British Columbia

I'm pleased to release the attached Interim Guidance for Commercial Thinning – Interior British Columbia. This guidance builds on the 1999 *Guidelines for Commercial Thinning* (Ministry of Forests, 1999). The objective of this guidance is to support professionals in the planning and implementation of commercial thinning (CT) operations for timber volume and value objectives in the BC interior. The guidance describes:

- Key principles to guide the use of commercial thinning in the interior,
- Examples of where and how commercial thinning should be applied,
- Examples of how commercial thinning can be incorporated into timber supply review and forest landscape planning, and
- Example stocking standards that maintain an economically valuable supply of commercial timber.

Guidance is a fundamental part of the Forest and Range Practices Act framework and is intended to support both operational and statutory decision-making for stands proposed for a commercial thinning treatment. It provides clarity on government expectations for the use of Crown resources, and enables professionals to plan, design and implement commercial thinning across the landscape.

This is the culmination of a significant effort by government, industry, and consulting professionals involved with this phase of the Provincial Commercial Thinning Project. I appreciate the work they continue to undertake on behalf of the people of British Columbia.

The Ministry's Stand Tending website has been updated to include this guidance and all supporting documentation, such as field forms, and the information required to complete growth and yield modelling on a specific stand. The guidance and companion documents can be found at https://www2.gov.bc.ca/gov/content/industry/forestry/managing-our-forest-resources/silviculture/stand-tending.

The Interior Appraisal Manual will be updated in July 2021 to reflect this guidance in the criteria for the tabular stumpage rate. Stands that do not meet the criteria will be appraised as a partial cut.
