Reference Coast Prices Information Paper: Calculation of Coast Log Prices (gov.bc.ca). For the October 2023 one-month data set, the average market value (AMV) for pure old growth is 196.51 \$/m3 and for mixed growth 68.45 \$/m3. The volume of pure old growth reported is 46,557.03 m3 and for mixed growth it is 137,590.58 m3.

Note (2) Three month totals may not equal the sum of previously published one month totals due to late or revised. Data is adjusted for Section 136 of the Forest Act.
