Reference Coast Prices Information Paper: Calculation of Coast Log Prices (gov.bc.ca). For the October 2023 three-month data set, the average market value (AMV) for pure old growth is 239.25 \$/m3 and for mixed growth 83.06 \$/m3. The volume of pure old growth reported is 184,534.487 m3 and for mixed growth it is 305,115.05 m3.

**Note (2)** Three month totals may not equal the sum of previously published one month totals due to late or revised. Data is adjusted for Section 136 of the Forest Act.
