

Logging Access Information:

Logging accesses on all side roads require a permit as well as logging accesses off of any numbered highway route.

It is helpful if the client provides site photos where possible. For accesses instruct the client to stand at the entrance of the proposed access and take photos of the sight distance in each direction and one photo of the entrance from the opposing shoulder of the road.

Logging Access Requirements:

- 9 metre top
- Minimum culvert size is 0.500mm x 12 metres
- 1 to 1 1/2 slope from top of running surface to bottom of toe
- Minimum of 0.300mm of top over culvert, with a minimum of this to be 0.150mm of crush gravel
- Sight distance is dependant upon the speed limit, please check with the Development Approvals staff

On any type of access we accept CSP culverts or the Black (Big "O") Plastic pipe. Any variations to the standards please again refer to the Development Approvals staff. For more information please click on our website below.
