Re: Apportionment – Pacific Timber Supply Area


I hereby revise the apportionment for the Pacific Timber Supply Area (TSA) in accordance with Section 10 of the *Forest Act*. The revision is a result of the deletion of area from Tree Farm Licence 46, and the addition to the Pacific TSA, supporting 12,391 m<sup>3</sup>/year, in allowable annual cut (AAC).



This memo also corrects an administrative error within my September 14, 2011 apportionment decision. The AAC available for non-replaceable forest licences (First Nations) should have been stated as 99,204 m<sup>3</sup>/year – not 50,574 m<sup>3</sup>/year.

The apportionment for the Pacific Timber Supply Area is as follows:
