

## Interfor Corporation Proposed Tenure Disposition in the Sunshine Coast Timber Supply Area

### **Purpose of this Document**

This document provides detail on several tenure dispositions proposed by Interfor Corporation (Interfor) in the Sunshine Coast timber supply area (TSA). The dispositions include the sub-division of a replaceable Forest Licence (RFL) and the transfer of several RFLs to new tenure holders. These tenure dispositions require the approval of decision makers in the Ministry of Forests (the "Ministry"). Details on the legal requirements for these approvals and the process the ministry will employ to determine if the dispositions should be approved, can be found in the document titled "Interfor Corporation Proposed Tenure Disposition in Coast British Columbia". ## **Details of the Disposition Requests**

The ministry has received applications from Interfor to complete the following tenure changes in the Sunshine Coast TSA:

- The subdivision of RFL A19220 with an allowable annual cut (AAC) of 181,031 m<sup>3</sup> into an amended A19220 with an AAC of 81,031 m<sup>3</sup>, the creation of a new RFL A98741 with an AAC of 18,550 m<sup>3</sup>. And the creation of another new RFL A98809 with an AAC of 81,450 m<sup>3</sup>.
- 2. The transfer of the amended A19220 to the Klahoose Forestry Limited Partnership.
- 3. The subsequent transfer of the A98741 to the Klahoose First Nation.
- 4. The subsequent transfer of A98809 with an AAC of 81,450 m<sup>3</sup> to the Klahoose Forestry Limited Partnership.
- 5. The transfer of A19224 with an AAC of 81,450 m<sup>3</sup> to the Tsain-Ko Forestry Development Partnership (Shishalh First Nation).
- 6. The transfer of A98515 with an AAC of 40,000 m<sup>3</sup> to the Tsain-Ko Forestry Development Partnership (Shishalh First Nation).

### What is a Replaceable Forest Licence and what rights are being provided?

RFL's are a form of forest tenure that provides harvesting rights in a TSA. RFLs are replaced every 10 years with a new term of 15 years. Details of the RFLs being subdivided and/or transferred follow:

The new A98741 and A98809 will have terms where the replacement and expiry aligns with the dates in the original A19220.

## Are there other Tenures or Permits that will be transferred?

Interfor has indicated that some road permits (RP), cutting permits (CP), and licences of occupation will be transferred in whole or in part to the new tenure holders. In addition, some Special Use Permits (SUP) and Licences of Occupation (LOO) will be assigned to the new tenure holders or surrendered and the new tenure holder will apply for new SUPs or a Licence of Occupation under the *Land Act*.

### Where will the RFLs be allowed to operate?

The RFLs will provide the holder with the right to apply for CPs and RPs within the Sunshine Coast TSA. The approval of the CPs and RPs will require consultation with First Nations and the approval of the District Manager to ensure they meet all legal requirements.

The Sunshine TSA occupies a portion of the south coast of British Columbia about 100 km north of Vancouver. It is within the South Coast Natural Resource Region and is administered by the B.C. government's Sunshine Coast Natural Resource District office in Powell River. A map of the Sunshine Coast TSA is attached.

It is a common practice for tenure holders in a TSA to enter into an operating area agreement to restrict their operations to a certain area of the TSA. This arrangement avoids tenure holders from overlapping operations and helps to ensure orderly planning and operations in the TSA. These operating area arrangements are business to business arrangements by tenure holders and are not mandated by the ministry.

It is expected that the amended A19220, new A98741, new A98809, A19224, and A98515 will initially restrict their operations to the areas historically allocated to Interfor for each RFL, and any future operating area changes will be done through discussion with other tenure holders in the Sunshine Coast TSA.



## What harvest rights have been provided in the Sunshine Coast TSA?

The Chief Forester set an AAC for the Sunshine Coast TSA of 1,204,808 m<sup>3</sup> on August 22, 2013. The Minister subsequently allocated or apportioned the Sunshine Coast TSA AACs into Forest Licences and for use by BC Timber Sales on September 13, 2013 as follows:

## How is the Allowable Annual Cut set for the Sunshine Coast TSA?

The Forest Act requires the chief forester to review the timber supply for each TSA at least once every 10 years and in most cases determine a new AAC. For the Sunshine Coast TSA, work on determining a new AAC commenced in 2021 with the release of a data package (found here: <u>SunshineCoastDataPackage</u>). The data package contains information that will be used to determine the new AAC such as the forest management regime, applicable land use plans, and legal objectives established by the Forest and Range Practices Act. First Nations consultation and a public review has been conducted on the data package that will be considered by the chief forester in determining a new AAC for the Sunshine Coast TSA.

Once the new AAC is established, the minister may adjust the apportionment (allocation) of timber harvesting rights assigned to specific tenure types. In instances where the new AAC is lower than the current AAC, the minister may proportionately reduce the AAC assigned to RFLs in the TSA. No compensation is provided by government when an RFLs timber harvesting rights are reduced by proportionate reduction due to a lower AAC being set by the chief forester.

## Are manufacturing facilities involved in the transaction?

There are no timber processing requirements with the license.

#### Is there contracting requirement associated with the RFLs?

There are four replaceable contractors with contracting rights on the RFLs. Information on contractor rights as a result of tenure sub-division and transfer can be found here: Information on Contractor Rights.

### What happens to existing license obligations, such as silviculture?

The new RFL holders will assume the new obligations associated with the licence including paying stumpage and the future silviculture responsibilities.

The responsibility to meet the outstanding obligations associated with road permits and silviculture requirements are still being determined between Interfor and the proposed new RFL holders.

### How will harvest operations be conducted?

Interfor has advised the Ministry that the new tenure holders Klahoose First Nation and Klahoose Forestry Limited Partnership will be added to Interfor's existing forest stewardship plan #20. This will require a major amendment under the Forest and Range Practices Act. Tsain-ko Forestry Development Corporation will amend their existing FSP to include additional areas.
