1. Applicant - Malcolm James Dobie
2. Date of application - March 31, 1969
3. Application approved by letter out October 6, 1970.
4. Terms of approval:
 - Lease with option to purchase
 - Subject to survey (10 acres)
 - Construction of Habitable Dwelling
5. Dobie is a natural born Canadian citizen
6. Location of area - near Nass Camp about 60^N miles of Terrace
7. Survey confirmed October 18, 1971
8. Purpose of lease - "Residential"
9. A " Home Acquisition Act" grant of \$1,000 was approved in 1972
10. Applicant applied to exercise option to purchase on June 22, 1972
11. Inspection report October 23, 1972 states:
 1. Habitable dwelling - 24 x 36 ft. A-frame house
 2. Lessee in permanent residence
12. Purchase price and fees totalling \$1,296 paid in full Nov. 8/72
13. The subject land is located within TFL #1 and has not yet been removed.
14. It is recommended therefore that the attached "Amendment Number 66" of TFL 1 be presented for signature of the Minister.

IN THE MATTER OF TREE FARM LICENCE NUMBER 1
AMENDMENT NUMBER 66

Whereas the lands described hereinafter are within Tree Farm Licence Number 1 and are found to be required for a higher economic use than the growing of forest crops;

And whereas the withdrawal of the aforementioned lands together with any lands previously withdrawn does not diminish the productive capacity of the licence area to the extent provided in Clause 10 of the Tree Farm Licence.

Therefore pursuant to Subsection (14) of Section 36 of the Forest Act being Chapter 153 of the Revised Statutes of British Columbia 1960 and pursuant to Clause 10 of the said Tree Farm Licence Number 1 the following lands are hereby withdrawn from the lands described in Schedule "B" of the said Tree Farm Licence, that is to say all that parcel or tract of land being more particularly shown in bold black on the sketch attached hereto and described as follows:

"Block A of Lot 453, Cassiar District
containing 10 acres more or less."

and the said lands so withdrawn are and shall be henceforth no longer subject to or form any part of the said Tree Farm Licence Number 1.

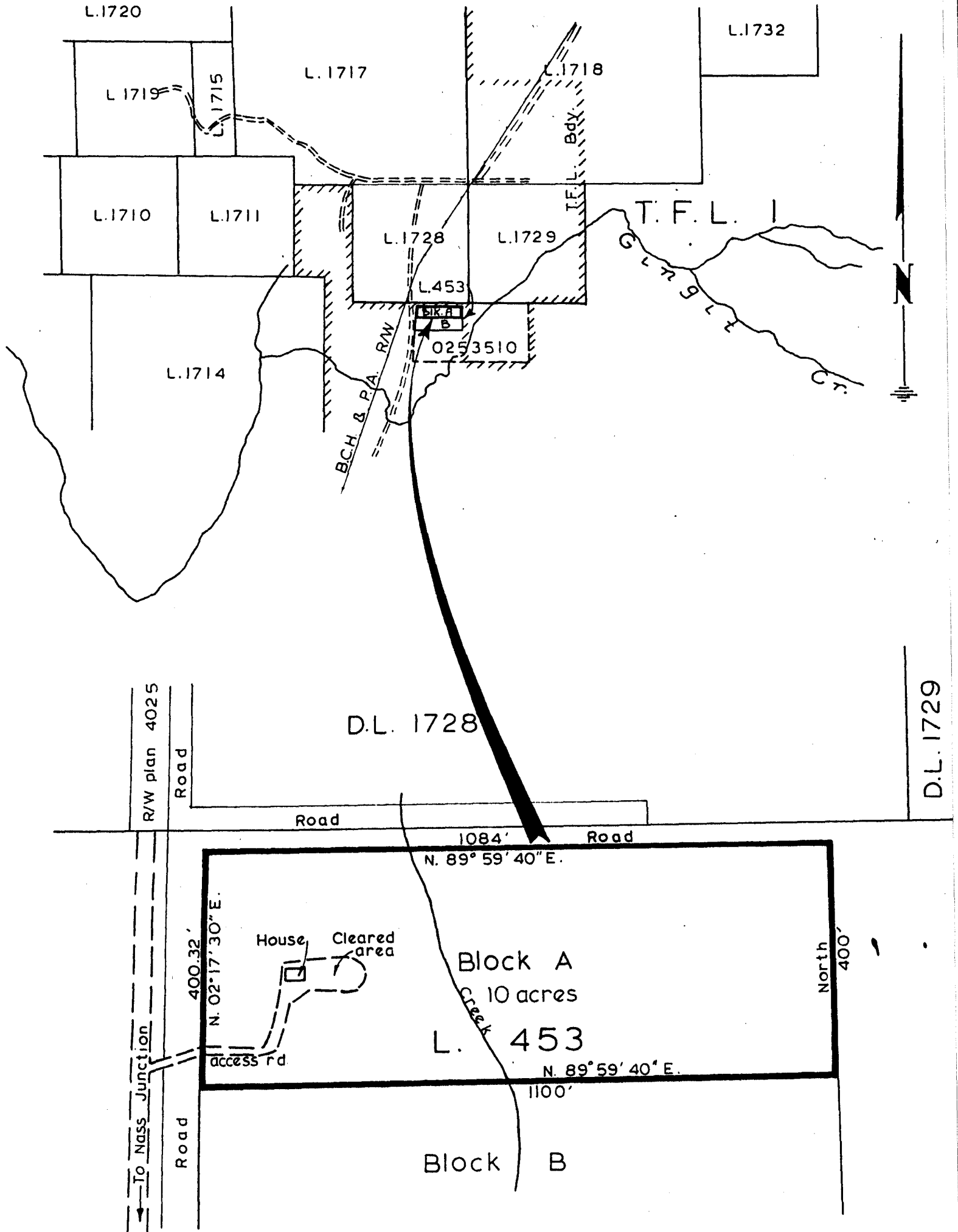
