Hundred and Sixty-One,

BETWEEN:

THE MINISTER OF LANDS AND FORESTS of the Province
of British Columbia, who, with his successors in
office, is

hereinafter called "the Licensor", of the one part,

AND

PASSMORE LUMBER COMPANY LIMITED, a corporation
duly incorporated under the laws of the Province
of British Columbia, and having its registered
office in the City of Nelson in the said Province,

hereinafter called "the Licensee" of the other part.

WHEREAS by an Indenture dated the first day of February,
in the year of Our Lord One Thousand Nine Hundred and Fifty, the Licensor
did grant unto the Licensee the management of certain Crown lands therein
described subject to the terms and conditions set forth in the said
Indenture which said Indenture is known and referred to as the "Little
Slocan Tree Farm Licence" and is numbered three (3) in the Forest Service
Register of Tree Farm Licences and on the official atlas maps of the
Department of Lands and Forests;

AND WHEREAS pursuant to Subsection 14 of Section 36 of
the "Forest Act" being Chapter 153 of the Revised Statutes of British
Columbia for 1960, the Minister may add lands to the said Tree Farm
Licence and the Licensee has requested that the lands hereinafter
described be added to the said Tree Farm Licence;

AND WHEREAS pursuant to Clause 43 of the said Tree Farm
Licence the said Indenture may be amended and the parties hereto have
mutually agreed to amend the said Indenture as hereinafter set forth:

NOW THEREFORE THIS INDENTURE WITNESSETH THAT in consideration of the premises and mutual agreements hereinafter expressed, it is hereby agreed as follows:

(1) That Schedule "B" of the said Indenture dated the first day of February 1950 be and it is hereby amended to include the lands formerly covered by Timber Sales X39869, X42452 and Timber Licence 13053^P expired and the lands described henceforth shall be and are a part of the said Schedule "B" as if the said lands had been originally included in said Schedule "B".

(2) Subject to the terms of the Indenture the parties hereto confirm the said Indenture dated the first day of February 1950 in all other respects.

IN WITNESS WHEREOF the Licensor has executed these presents and the Licensee has hereunto affixed its corporate seal by the hands of its proper officer in that behalf.
