

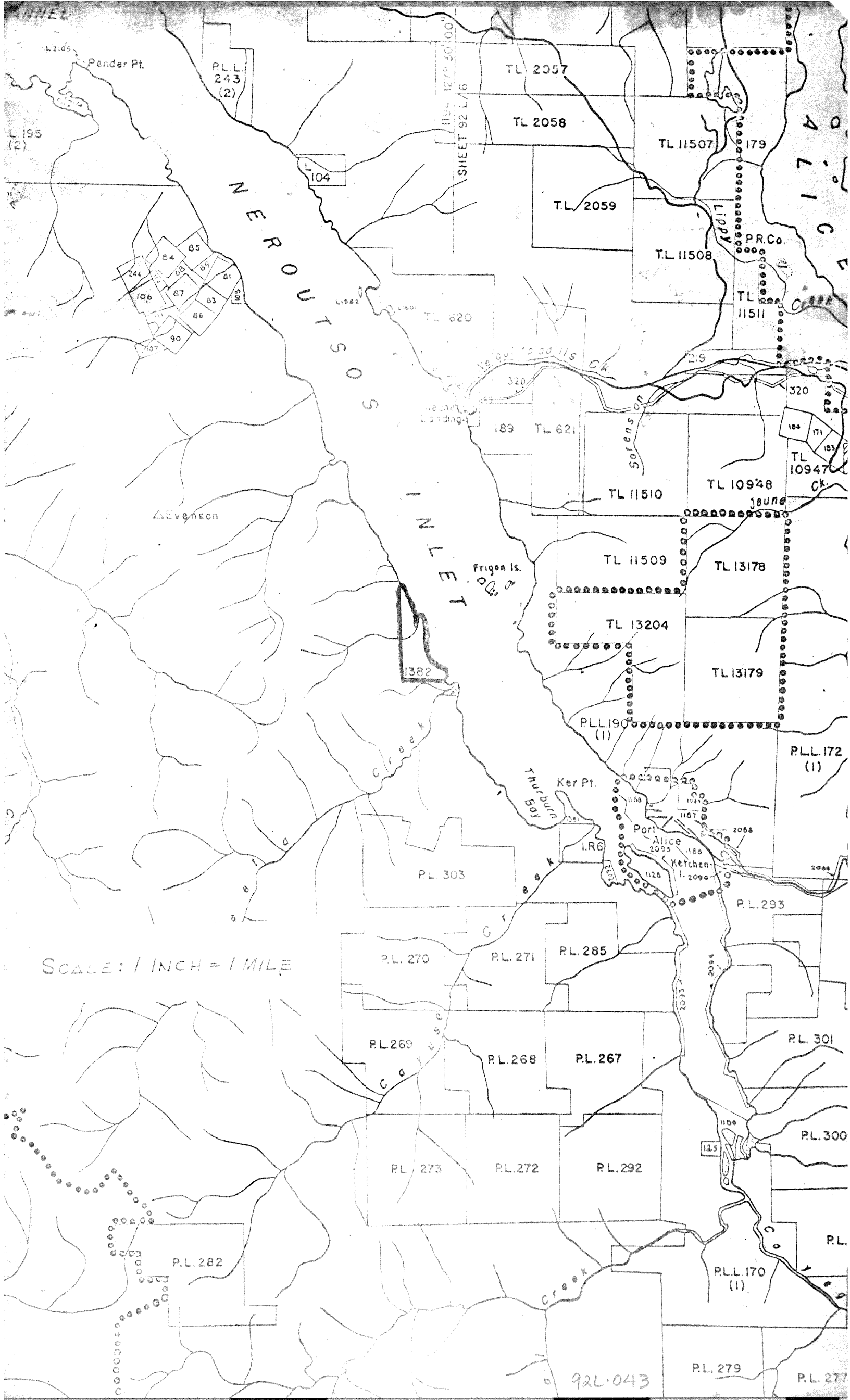
Notice has been received to the effect that Rayonier
