IN THE MATTER OF TREE FARM LICENCE NUMBER 6

AMENDMENT NUMBER 42

Whereas the lands described hereinafter are within Tree Farm Licence Number 6, (hereinafter referred to as "the Licence"), and are found to be suitable for a higher economic use than the growing of forest crops;

And whereas the Licensee has requested the withdrawal of those parts of the lands which are in Schedule "A" of the Licence;

Therefore pursuant to Clause 17 of the License, the Licensor hereby consents to the withdrawal from Schedule "A" of the Licence of the following lands:

- (1) The following described lands which are included within Certificates of Title Numbers 307126-I and 307127-I:
 - (a) "That part of Section Eleven (11) Township Thirty-seven (37) Rupert District, described as commencing at the North Westerly corner of said Section, thence Southerly along the Westerly boundary of said Section for 1287.3 feet more or less to the south-easterly corner of that part of the North East Quarter of Section Ten (10) Township Thirty-seven (37) Rupert District, shown outlined in green and marked Block "A" on Plan 1335 R.W., thence South 89°49' East for 2696.6 feet, thence Northerly for 1320 feet more or less to the South East corner of the South West Quarter (1/4) of Section Fourteen (14) Township Thirty-seven (37) Rupert District, thence Westerly along the Northerly boundary of said Section Eleven, for 2643.2 feet more or less to the point of commencement and containing 79.85 acres more or less."

(b) "That part of the North East Quarter of Section 4, Township 37, Rupert District, consisting of the strip One Hundred (100') feet wide shown uncoloured on Plan 1335 R.W. and containing 10.12 acres more or less and appurtenant to property described in (1) above."

(c) "That part of the strip of land 300 feet wide shown on Plan 1335 R.W. being uncoloured and lying within the North East 1/4 Section 4, Township 37, Rupert District, Except that part thereof lying within the area described as follows: That part of the North East 1/4 of Section 4, Township 37, Rupert District, consisting of the strip 100 feet wide shown uncoloured on Plan 1335 R.W. and containing 10.12 acres more or less."

(2) That certain road right-of-way, 100 feet in width, traversing Section 12 (Pulp Lease 339) and Section 13 (Pulp Lease 352), Township 37, and S.T.L. 8186P (Pulp Lease 337), Township 32, Rupert Land District, shown outlined in red on Plan 1335 R.W. and containing 17.45 acres.

and the lands so withdrawn from Schedule "A" are and shall henceforth no longer be part of or subject to the said Tree Farm Licence Number 6.


And further pursuant to Clauses 14 and 15 of the Licence, the following lands are herewith withdrawn from Schedule "B" of the Licence:
