WHEREAS:

- A. The parcel of land described hereinafter lies within Tree Farm Licence (TFL) 6, and is required for the expansion of Cluxewe Saltmarsh Reserve area;
- B. The Licensee has requested that the said parcel of land be withdrawn from Schedule "B" lands of TFL 6;
- C. The Licensor is in agreement with withdrawal of the aforementioned land from Schedule "B" of the said tree farm licence;

Pursuant to Section 39(1)(e) of the *Forest Act*, the licensee consents to the withdrawal from Schedule "B" of the said TFL 6 of the following parcel of land containing approximately 30 hectares, more or less, and more particularly shown outlined in bold black on the attached sketch to this instrument.
