WHEREAS:

- A. In accordance with the *Forest Act*, the Minister and the Licensee entered into a replacement agreement for Tree Farm Licence 14, dated March 1, 2000, and
- B. The Minister and the Licensee have mutually agreed to change the area of Tree Farm Licence 14 by removing 2.4 hectares from the Licence for use by ABC Wilderness Adventures Ltd.

THEREFORE:

In accordance with Section 39.1(1) of the *Forest Act*, the Minister, with the consent of the Licensee, changes the area of Tree Farm Licence 14 by removing the 2.4 hectares subject to the Tree Farm Licence agreement.

The Minister and the Licensee agree that the Tree Farm Licence 14 agreement is amended by the deletion of these lands.

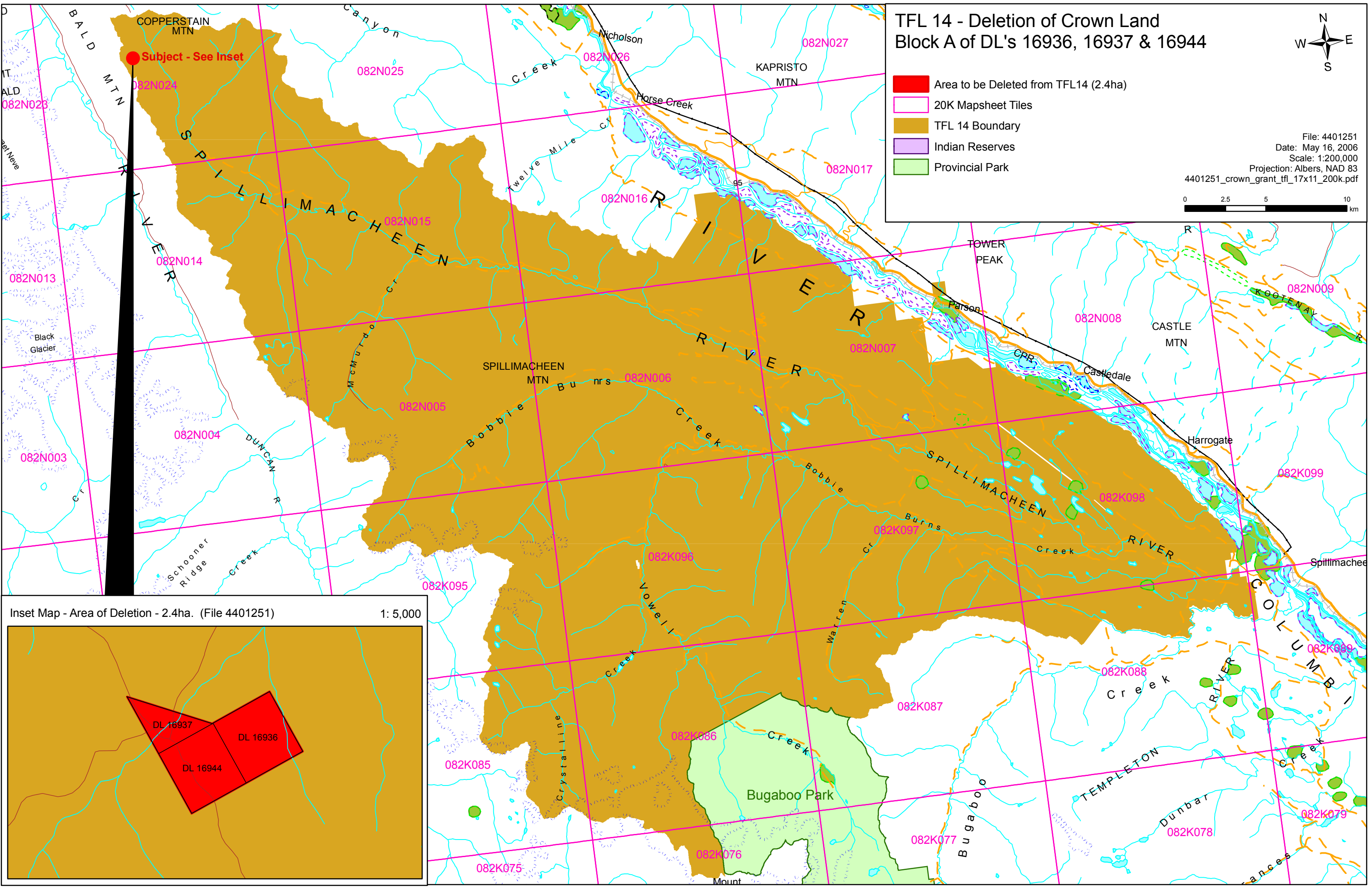
