

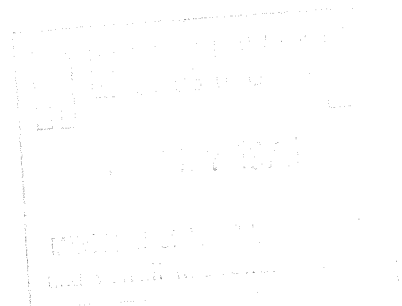

Whereas the land described hereinafter is within Tree Farm Licence Number 19 and is required for a right-of-way for the purpose of a Forest Service road;

Therefore pursuant to Clause 10 of the said Tree Farm Licence the following land; a road right-of-way 100 feet in width traversing all that unalienated and unencumbered Crown land, Nootka Land District, as shown in bold black on the attached sketch, is herewith withdrawn from Schedule "B" of the said Tree Farm Licence for the purpose of a right-of-way under Section 147 of the Forest Act.

The said land so withdrawn is and shall be henceforth no longer part of or subject to the said Tree Farm Licence Number 19.
