THIS INDENTURE made in duplicate this .....<sup>15<sup>TH</sup></sup> day of ...JUNE..... in the year of Our Lord one thousand nine hundred and sixty-five,

BETWEEN:

THE MINISTER OF LANDS, FORESTS, AND WATER RESOURCES of the Province of British Columbia, who, with his successors in office, is

hereinafter called "the Licensor", of the one part,

AND

CELGAR LIMITED, a Corporation duly incorporated under the laws of the Province of British Columbia, and having its registered office in the City of Vancouver in the said Province

hereinafter called "the Licensee", of the other part.

WHEREAS by an Indenture dated the 20th day of July, 1955, the Licensor did grant unto the Licensee a Tree Farm Licence which is referred to as the "Arrow Lakes Tree Farm Licence" and is numbered twenty-three in the Forest Service register of Tree Farm Licences and on the official atlas maps of the Department of Lands, Forests, and Water Resources;

AND WHEREAS pursuant to Subsection (14) of Section 36 of the Forest Act, being Chapter 153 of the Revised Statutes of British Columbia for 1960, the Minister may add lands to the said Tree Farm Licence, and the Licensee has requested the lands hereinafter described be added to the said Tree Farm Licence,

AND WHEREAS pursuant to Clause 48 of the said Tree Farm Licence the said Indenture may be amended and the parties hereto have mutually agreed to amend the said Indenture as hereinafter set forth:

NOW THEREFORE THIS INDENTURE WITNESSETH THAT in consideration of the premises and the sum of One Dollar (\$1.00) of lawful money of Canada now paid by the Licensee to the Licensor, the receipt whereof is hereby acknowledged, the parties hereto agree as follows:

(1) That Schedule "B" of the said Indenture dated the 20th day of July, 1955 is amended to include the lands covered by expired Timber Sales numbered X31321, X57853, X60432, and being more particularly shown outlined in bold black on the three sketch maps attached hereto, and the above described lands henceforth shall be and are a part of Schedule "B".

(2) Subject to the terms of this Indenture the parties hereto confirm the said Indenture dated the 20th day of July, 1955 in all other respects and prior amendments hereto to the date hereof.

IN WITNESS WHEREOF the Licensor has executed these presents and the Licensee has hereunto affixed its corporate seal by the hands of its proper officers in that behalf.

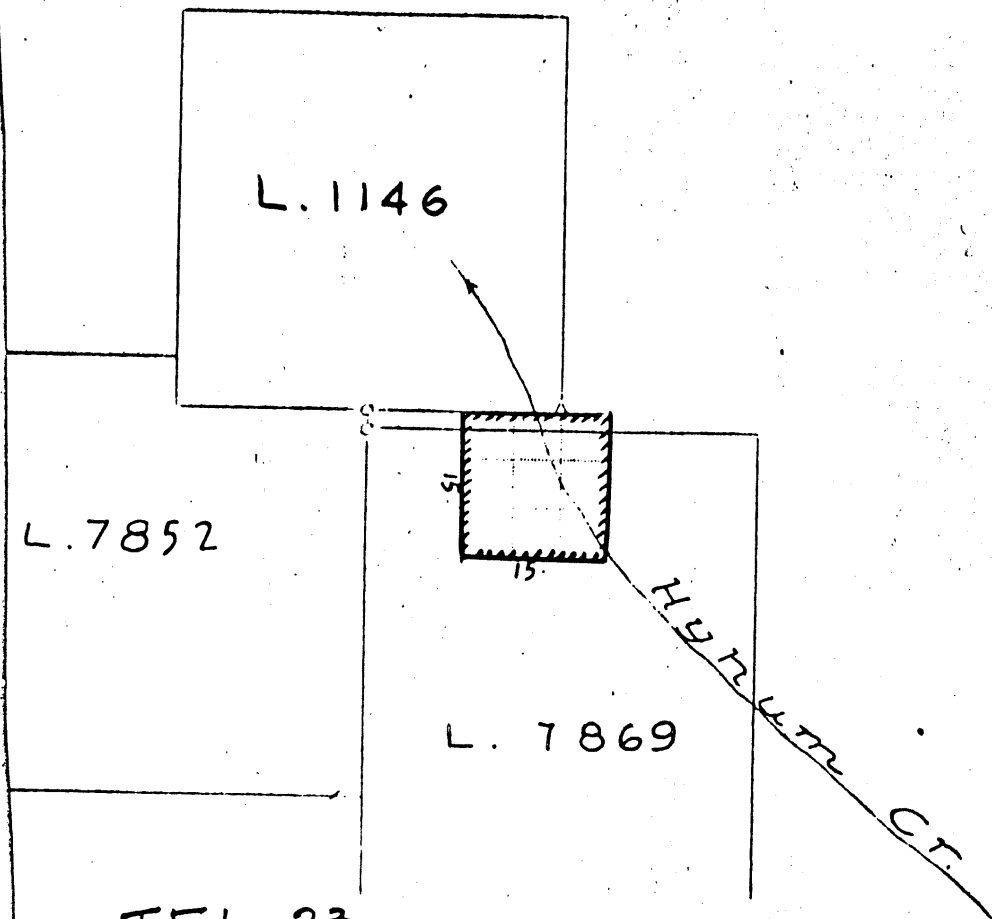

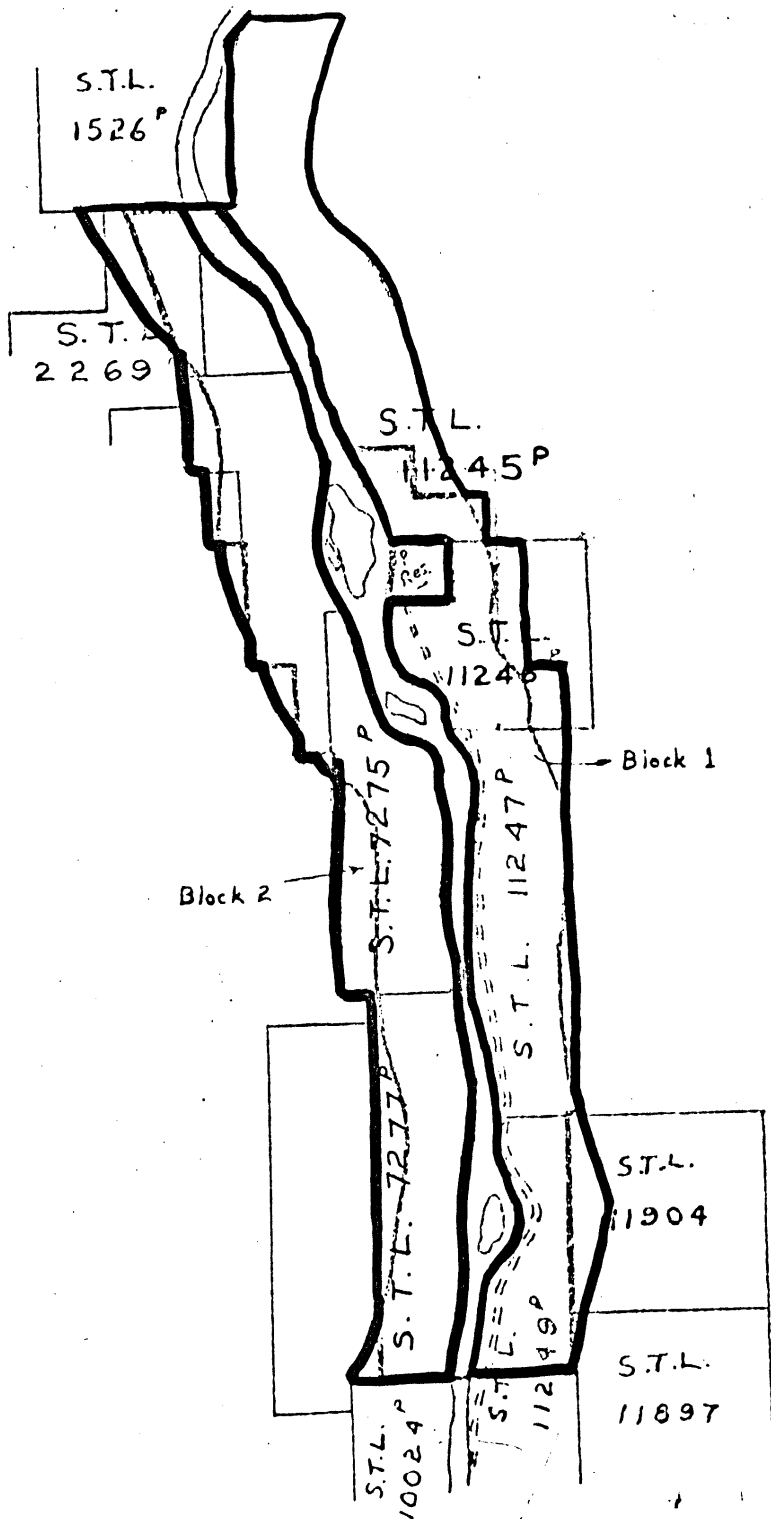
