IN THE MATTER OF TREE FARM LICENCE NUMBER 25

AMENDMENT NO. 7

THIS AGREEMENT made in duplicate this¹¹..... day of
...~~December 25~~..... in the year of Our Lord one thousand
nine hundred and fifty-nine.

BETWEEN:

THE MINISTER OF LANDS AND FORESTS of the Province
of British Columbia, who, with his successors in
office, is

hereinafter called "the Minister", of the one part,

AND

RAYONIER CANADA LIMITED, formerly named
ALASKA PINE AND CELLULOSE LIMITED, a Corporation
duly incorporated under the laws of the Dominion
of Canada, and having its registered office in
the City of Vancouver in the said Province,

hereinafter called "the Licensee", of the other part.

WHEREAS pursuant to the provisions of Section 33 of the "Forest
Act", the Minister and the Licensee entered into an agreement dated
the 21st day of May 1958, known and referred to as the "Naka Tree
Farm Licence" which is numbered 25 on the Forest Service register of
Tree Farm Licences.

AND WHEREAS the parties hereto have mutually agreed to amend the
said agreement as hereinafter set forth.

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT in consideration of
the premises and mutual agreements hereinafter expressed, it is hereby
agreed as follows:

- (1) That Clause 2 of the said Agreement be and the same is
hereby deleted and replaced by the clause set forth below, which
shall be Clause 2 and be of the same force and effect as if such

clause had been originally incorporated in the said agreement in the place and stead of said Clause 2. The following is the replacing clause:

"2 (a) This licence is given for the maintenance of the manufacturing plant or plants operated by the licensee and its wholly owned subsidiaries. Said plant or plants shall be capable of using the allowable cut * from the licence area and such plant or plants shall be maintained in sufficient continuity to use a volume of wood equivalent to the wood product of the licence annually. The wood removed from this tree farm licence shall be either processed in the said manufacturing plant or plants or in substitution therefor an equivalent volume of wood shall be so processed; except such tree species or forest products as the Minister may approve in writing for disposal elsewhere.

(b) Provided that in respect of logs delivered to the Powell River Company Limited, or its successors under the provisions of a contract dated December 1st 1944, between Broughton Strait Timber Company Limited, Pioneer Timber Company Limited and Powell River Company Limited, and the contract dated 5th December 1944, between Powell River Company Limited and Pioneer Timber Company Limited, no logs need be obtained from other sources in substitution for use in the licensee's manufacturing plant or plants."

(2) That the said parties hereto subject to the terms of this agreement confirm in all other respects the said agreement dated the 21st day of May 1958, and all subsequent amendments thereto.

(3) This agreement shall be binding upon the Minister, and his successors in office and on the licensee, its successors and assigns.
