Whereas the parcel of land described hereinafter as District Lot 2306, Rupert District (0.375 hectares, more or less) lies within Tree Farm Licence Number 37, and is required by the Ministry of Environment, Lands and Parks for commercial (gas station and store) purposes:

And whereas the Licensee has given his consent to the immediate withdrawal of the aforementioned parcel of Crown land from Schedule "B" of the said tree farm licence (see letter dated July 14, 1989);

And whereas the Licensee has waived his right to compensation for removal of the aforementioned parcel of Crown land;

Therefore, pursuant to Section 53(1)(b)(ii) of the *Forest Act*, the Licensor hereby withdraws the following parcel of land from Schedule "B" of the said Tree Farm Licence Number 37:

District Lot 2306, Rupert District, more particularly shown outlined in bold black on the attached plan dated May 4, 1995, totalling approximately 0.375 hectares, more or less;

And the said land so withdrawn shall be henceforth no longer part of or subject to the said Tree Farm Licence Number 37.

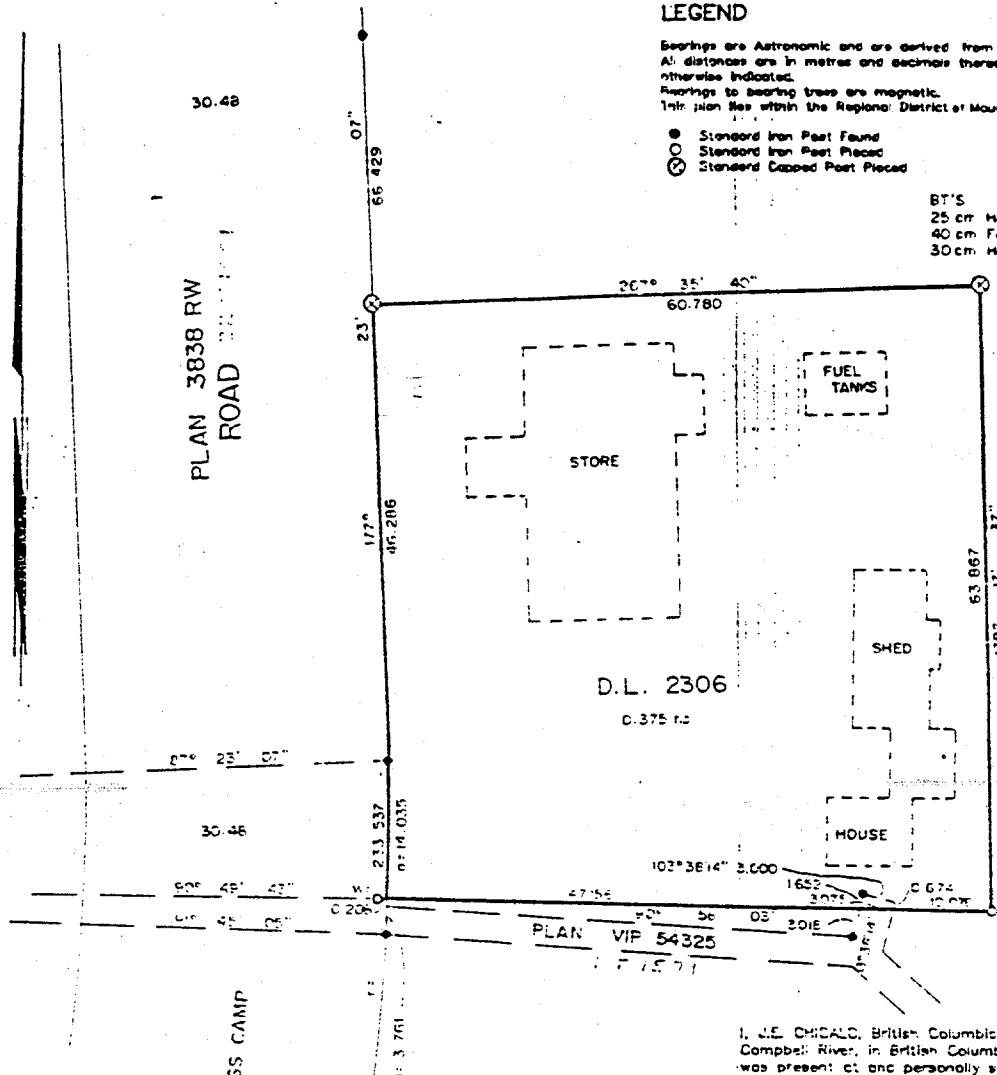
