IN THE MATTER OF TREE FARM LICENCE NUMBER 39

AMENDMENT NO. 32

Whereas parts of Lot 35 (T.L. 14057 expired) and Lot 1473 (T.L. 9404 expired) on Graham Island, Queen Charlotte Islands, are within Tree Farm Licence Number 39 and are found to be suitable for a higher economic use than the raising of forest crops.

And whereas the withdrawal of the aforementioned lands in no way affects the sustained yield management of the forest.

Therefore pursuant to Subsection (14) of Section 36 of the Forest Act being Chapter 153 of the Revised Statutes of British Columbia 1960 and pursuant to Clause 11 of the said Tree Farm Licence the following lands are herewith withdrawn from the lands described in Schedule "B" of the said Tree Farm Licence, and being more particularly shown outlined in red on the attached sketch:


AREA 1: "Commencing at a point on the shore of Ian Lake, said point being approximately 70 chains north and 4 chains east of the northeast corner of Lot 33, Queen Charlotte Islands; thence north 3 chains; thence east 4 chains; thence south 3 chains, more or less, to the shore of Ian Lake; thence following said lakeshore in a westerly direction to point of commencement. (1.2 acres).

AREA 2: Commencing at a point on the shore of Ian Lake, said point being approximately 5 chains west and 48 chains north of the northeast corner of Lot 33, Queen Charlotte Islands; thence east 3 chains; thence north 5 chains, more or less, to the shore of Ian Lake; thence following said lakeshore in a southwesterly direction to point of commencement. (1.0 acres).

Total acreage: (2.2)."

and the said lands so withdrawn are and shall be henceforth no longer subject to or form any part of the said Tree Farm Licence during the lifetime of Special Use Permit Number 5051.
