IN THE MATTER OF TREE FARM LICENCE NUMBER 39

AMENDMENT NO. 36

---

Whereas a right-of-way for the purpose of removal of forest products is required over the lands described hereinafter which said lands are within Tree Farm Licence Number 39.


Therefore pursuant to Clause 12 of the said Tree Farm Licence Number 39 the following lands are herewith withdrawn from the lands described in Schedule "B" of the said Tree Farm Licence that is to say a logging road right-of-way 40 feet in width being more particularly shown outlined in red on the attached sketch and described as follows:

1. "Commencing at a point on the westerly shore of Haslam Lake, New Westminster Land District, being a point immediately east from the intersection of the east boundary of Lot 916 with the said westerly shore; thence in a general northwesterly and northeasterly direction to a point on the west boundary of Timber Sale X89298; said point being approximately 6 chains north from the most westerly southwest corner of Timber Sale X89298; save and excepting thereout that portion traversing Lot 2257-T.L. 2433p and totalling 133 chains in length."
2. "Commencing at a point on the above described logging road being a point approximately 20 chains west and 6 chains north from the most westerly southwest corner of Timber Sale X89298; thence northerly and easterly to a point on the west boundary of Timber Sale X91145, said point being approximately 3 chains north from the most westerly southwest corner of said Timber Sale X91145 and totalling approximately 18 chains in length."

for the purpose of a right-of-way under Part VI of the Forest Act for the period necessary for the removal of forest products from Timber Sales X89298 and X91145 or any extension or resale thereof and the said lands so withdrawn are and shall be henceforth no longer subject to or form any part of the said Tree Farm Licence during the lifetime of Special Use Permit No. 2462.

This Amendment cancels and replaces Amendment Number 25  
dated the 8th day of April, 1963.
