IN THE MATTER OF TREE FARM LICENCE NUMBER 39  
AMENDMENT NUMBER 61

THIS AGREEMENT made in duplicate this 31<sup>st</sup> day of  
MARCH in the year of Our Lord one thousand nine hundred and  
sixty-six,

BETWEEN:

THE MINISTER OF LANDS, FORESTS, AND WATER RESOURCES  
of the Province of British Columbia, who, with his  
successors in office, is

hereinafter called "the Minister",

OF THE ONE PART,

AND

MACMILLAN, BLOEDEL AND POWELL RIVER LIMITED, a  
corporation duly incorporated under the laws of  
the Province of British Columbia, and having its  
registered office in the City of Vancouver in the  
said Province,

hereinafter called "the Licensee",

OF THE OTHER PART.

WHEREAS by an Agreement dated the 27th day of October 1961 the  
Minister did grant unto the Licensee a Tree Farm Licence (hereinafter  
called "the Licence") which is known and referred to as the "Haida Tree  
Farm Licence" and is numbered thirty-nine (39) in the Forest Service  
register of Tree Farm Licences and on the official atlas maps of the  
Department of Lands, Forests, and Water Resources;

AND WHEREAS pursuant to Clause 49 of the Licence the said  
Agreement may be amended and the parties hereto have mutually agreed to  
amend the said Agreement as hereinafter set forth;

AND WHEREAS Special Use Permit Number 3967 was in good standing at the date of signing the said Agreement and it is now desirable to amend the said Special Use Permit in certain respects and it is also desirable to provide for the automatic reversion to Schedule "B" of the Licence of the permit area upon termination of its use;

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT in consideration of the premises and the sum of One Dollar (\$1.00) of lawful money of Canada now paid by the Licensee to the Minister, receipt whereof is hereby acknowledged, the parties hereto agree as follows:

(1) THAT that portion of Special Use Permit Number 3967 shown coloured green on the sketch attached hereto is herewith incorporated in Block 1 of Schedule "B" of the Licence and the lands so incorporated are and shall be henceforth part of and subject to the Licence.

(2) THAT that portion of Special Use Permit Number 3967 shown coloured red on the sketch attached hereto remains excluded from the lands described in Block 1 of Schedule "B" of the Licence during the lifetime of Special Use Permit Number 5705 (to be issued in place of Special Use Permit Number 3967 in part) and upon expiry or cancellation of the said Special Use Permit Number 5705 the permit area shall forthwith be included within the lands described in Block 1 of Schedule "B" of the Licence.

(3) THAT that portion of Special Use Permit Number 3967 shown coloured blue on the sketch attached hereto remains excluded from the lands described in Block 1 of Schedule "B" of the Licence during the lifetime of the said Special Use Permit Number 3967 as amended 22nd November 1965 and upon expiry or cancellation of the said Special Use Permit Number 3967 the permit area shall forthwith be included within the lands described in Block 1 of Schedule "B" of the Licence.

(4) THAT that certain right-of-way, 40 feet in width, shown in the dashed blue line on the sketch attached hereto and being an extension to Special Use Permit Number 3967 is herewith withdrawn from the lands described in Block 1 of Schedule "B" of the Licence and the area so withdrawn is and shall be henceforth no longer part of or subject to the Licence during the lifetime of Special Use Permit Number 3967 as amended 22nd November 1965

(5) THAT subject to the terms of this Agreement the parties hereto confirm in all other respects the said Agreement dated 27th day of October 1961 and amendments thereto to the date hereof.

IN WITNESS WHEREOF the Minister has executed these presents and the Licensee has hereunto affixed its corporate seal by the hands of its proper officers in that behalf.

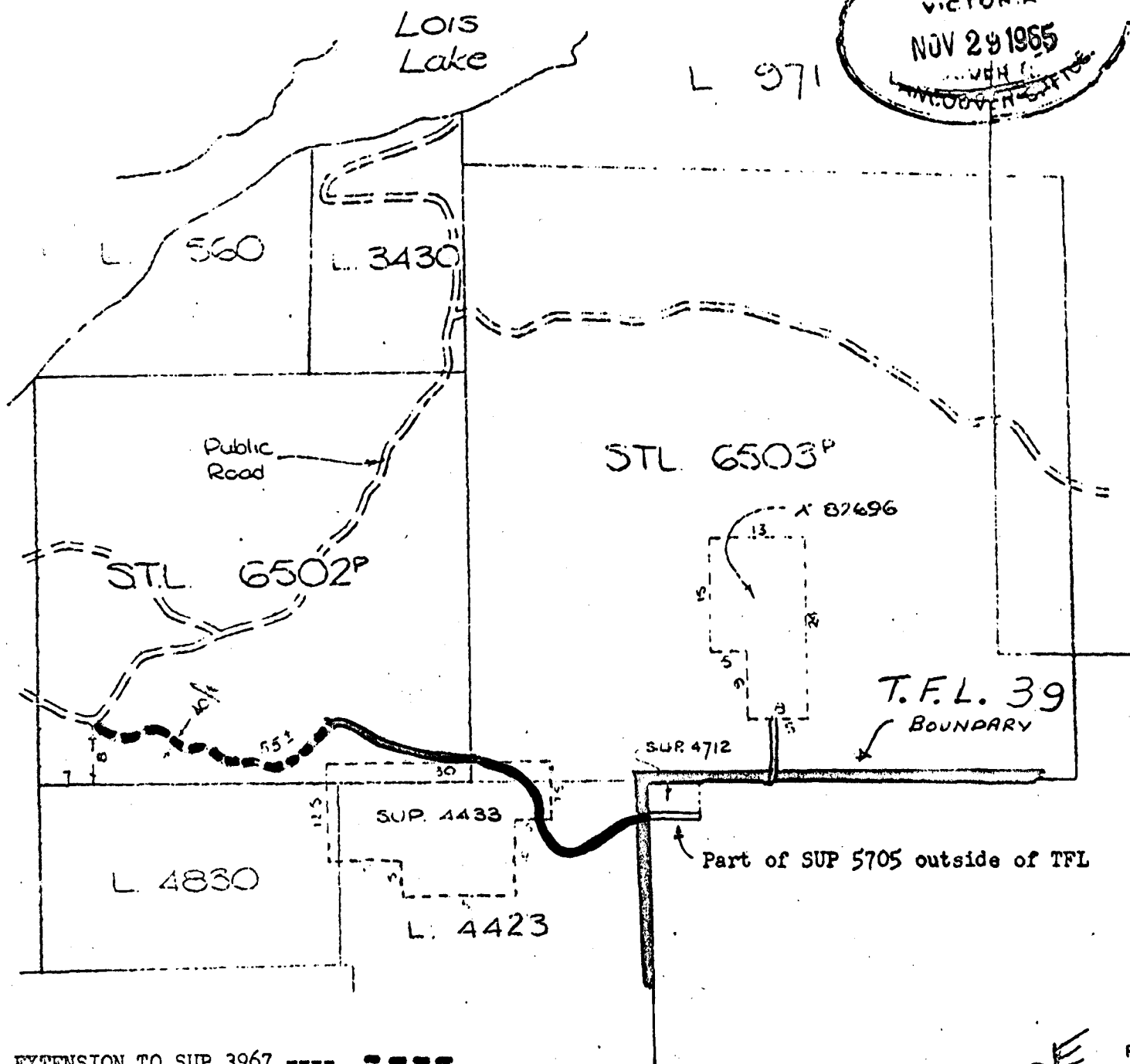
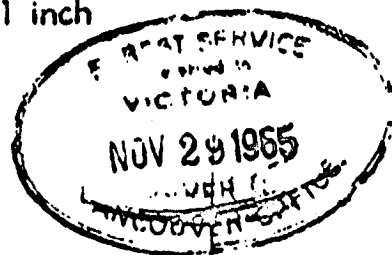
# MAP OF SUP. ~~3967~~


