AMENDMENT NO. 67

THIS INDENTURE made in duplicate this day of
..... in the year of Our Lord One Thousand Nine Hundred
and Sixty-seven,

BETWEEN:

THE MINISTER OF LANDS, FORESTS, AND WATER RESOURCES,
of the Province of British Columbia, who, with his
successors in office, is hereinafter called "the
Licensor"

OF THE ONE PART

AND

MACMILLAN BLOEDEL LIMITED, a Corporation duly in-
corporated under the laws of the Province of British
Columbia, and having its registered office in the
City of Vancouver, in the said Province, hereinafter
called "the Licensee"

OF THE OTHER PART.

WHEREAS by an Agreement dated the 27th day of October, 1961,
and made pursuant to the Forest Act being Chapter 153 of the Revised
Statutes of British Columbia 1960, and amendments thereto, the Licensor
did grant unto the Licensee a Tree Farm Licence, which is referred to as
the "Haida Tree Farm Licence" and is numbered thirty-nine (39) on the
Forest Service register of Tree Farm Licences and on the official atlas
maps of the Department of Lands, Forests, and Water Resources;

AND WHEREAS certain errors occurred in the descriptions of the
said lands set out in Schedule "A" to the said Tree Farm Licence and the
parties hereto have mutually agreed that the said Agreement be amended
as hereinafter set forth;

NOW THEREFORE THIS INDENTURE WITNESSETH THAT in consideration
of the premises and the sum of One Dollar (\$1.00) of lawful money of
Canada, now paid by the Licensee to the Licensor, the receipt whereof
is hereby acknowledged, the parties hereto agree as follows:

(1) That Schedule "A", Page 7, Block 4 be amended by deleting "S. $\frac{1}{2}$ of the N.W. $\frac{1}{4}$ and N. $\frac{1}{2}$ of the S.W. $\frac{1}{4}$ Sec. 26, Tp. 9 Rupert District, 186.84 acres" and inserting in its stead "N. $\frac{1}{2}$ of the S.W. $\frac{1}{4}$ and that part of S. $\frac{1}{2}$ of the N.W. $\frac{1}{4}$ lying south of Lot 667, Sec. 26 Tp. 9 Rupert District, 150 acres"

(2) That the plan attached to the licence showing Block 4 as referred to in clause (5) of the licence be deleted and the attached plan substituted in its stead.

(3) Subject to the terms of this Indenture the parties hereto confirm the said Agreement dated the 27th day of October, 1961 and prior amendments to the date hereof in all other respects.

(4) This Indenture shall be binding upon the Licensor and his successors in office, and upon the Licensee, its successors and assigns.

IN WITNESS WHEREOF the Licensor has executed these presents and the Licensee has hereunto affixed its corporate seal by the hands of its proper officers in that behalf.

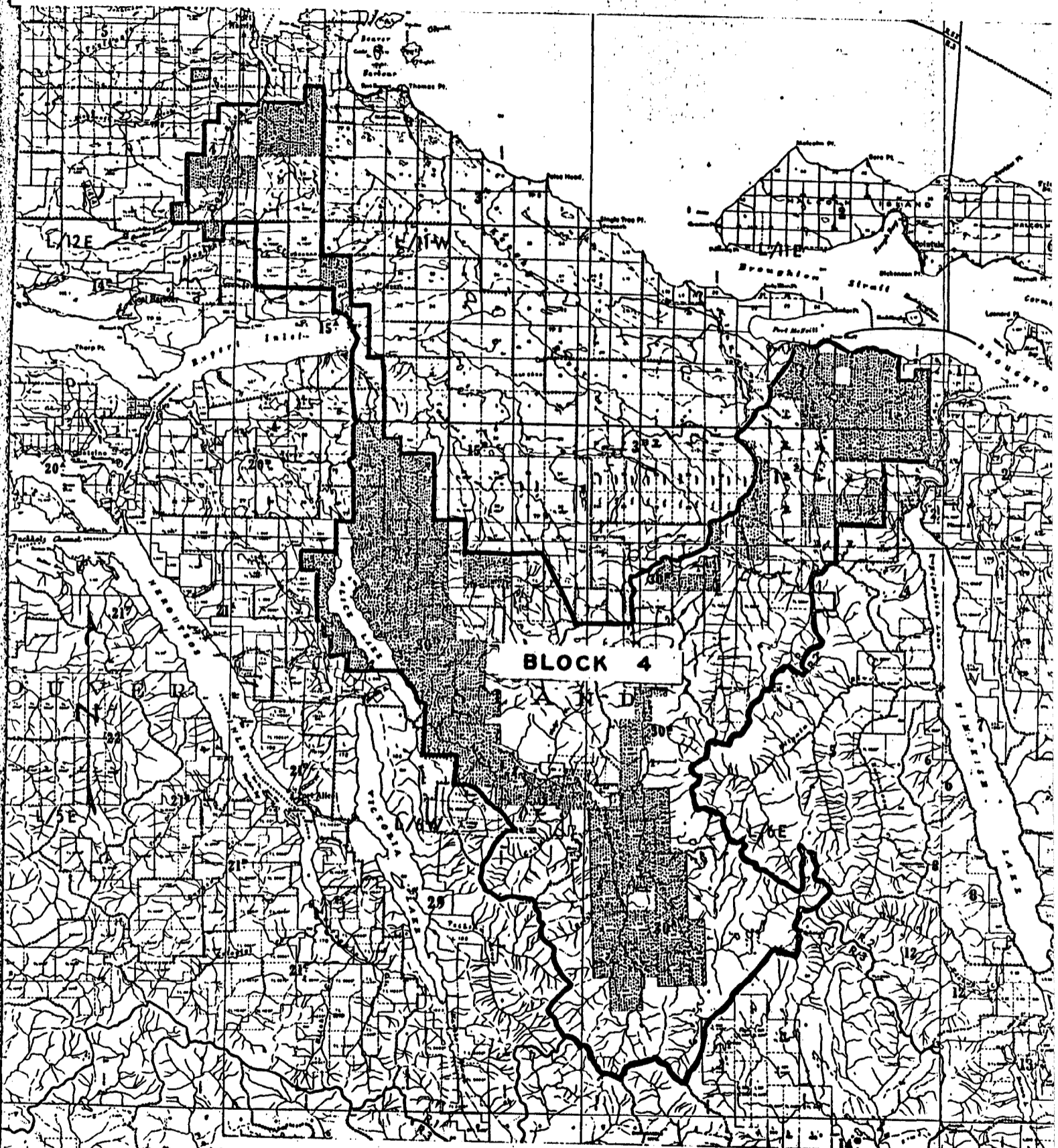
