And whereas the withdrawal of the aforementioned lands will not effect the sustained yield management of the said Tree Farm Licence;

Therefore pursuant to subsection (14) of Section 36 of the Forest Act being Chapter 153 of the Revised Statutes of British Columbia, 1960 and pursuant to Clause 11 of the said Tree Farm Licence the following lands are hereby withdrawn from the lands described in Schedule "B" of the said Tree Farm Licence and more particularly described as follows:

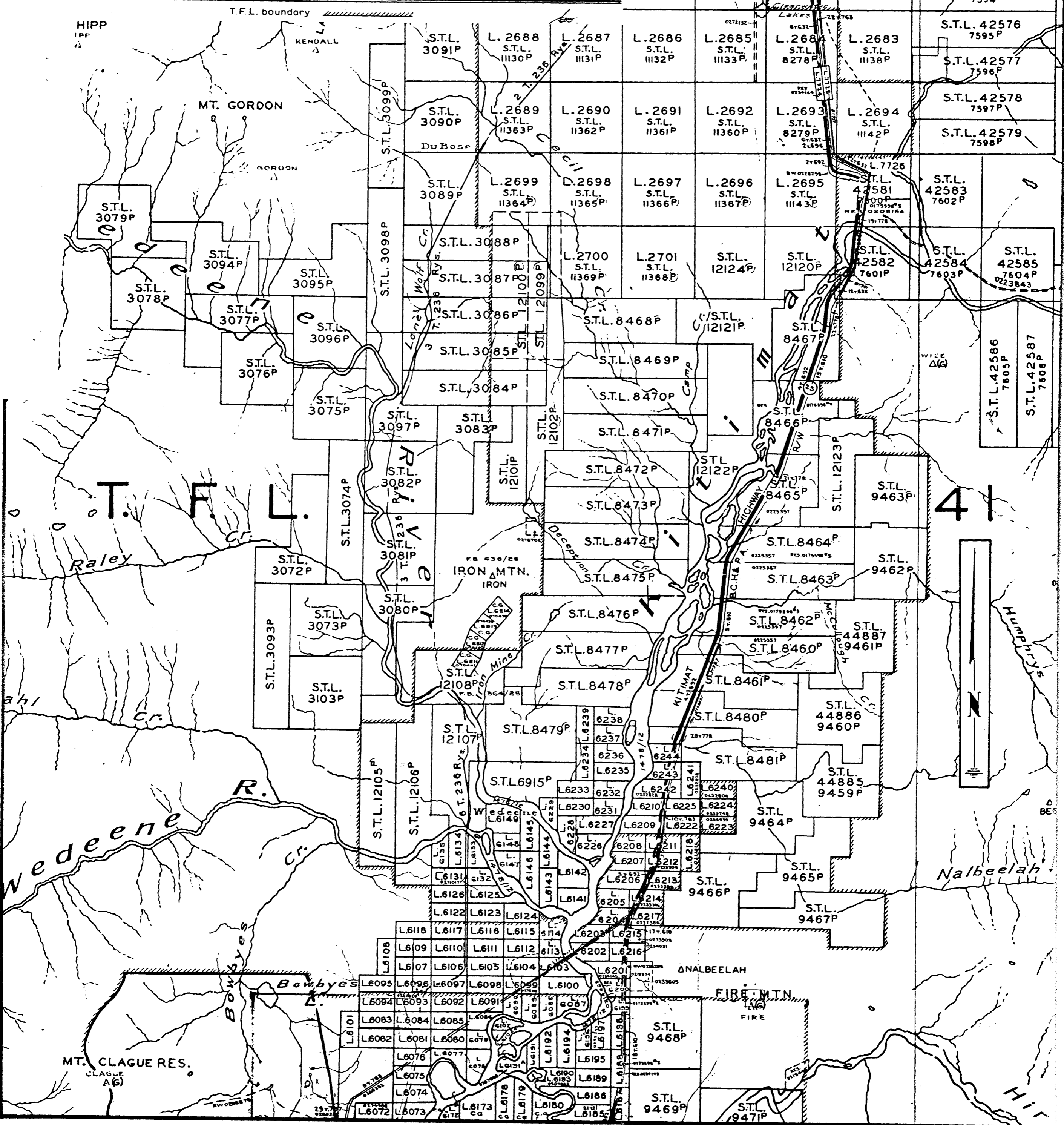
