WHEREAS:

The Licensor and Licensee have entered into Tree Farm Licence No. 43 (the "TFL"), dated January 21, 1985, pursuant to Section 33.1 of the Forest Act of British Columbia; and

The parties have mutually agreed to amend the said Agreement;

THIS INDENTURE WITNESSES that, in consideration of One dollar (\$1.00) and other good and valuable consideration paid by the Licensee to the Licensor (the receipt and sufficiency of which the Licensor acknowledges), the parties agree as follows:

That Schedule "B" of the said Agreement be and it is hereby amended to include:

Island 6 lying within fractional Section 14 and fractional Section 23, Township 3, Range 30, West of the Sixth Meridian, New Westminster District (29 hectares, more or less)

That part of Island 20 lying within fractional Section 14, Township 3, Range 30, West of the Sixth Meridian, New Westminster District (30 hectares, more or less), as shown outlined in bold black on the attached sketch marked Exhibit "A" dated March 12, 1986.

That the parties hereto subject to the terms of this Indenture confirm in all other respects the said Agreement dated January 1, 1985.

This Indenture shall be binding upon the Minister and his successors in office and the Licensee, its successors and assigns.

IN WITNESS TO THIS INDENTURE, it has been signed on behalf of the Crown and it has been executed by the Licensee.

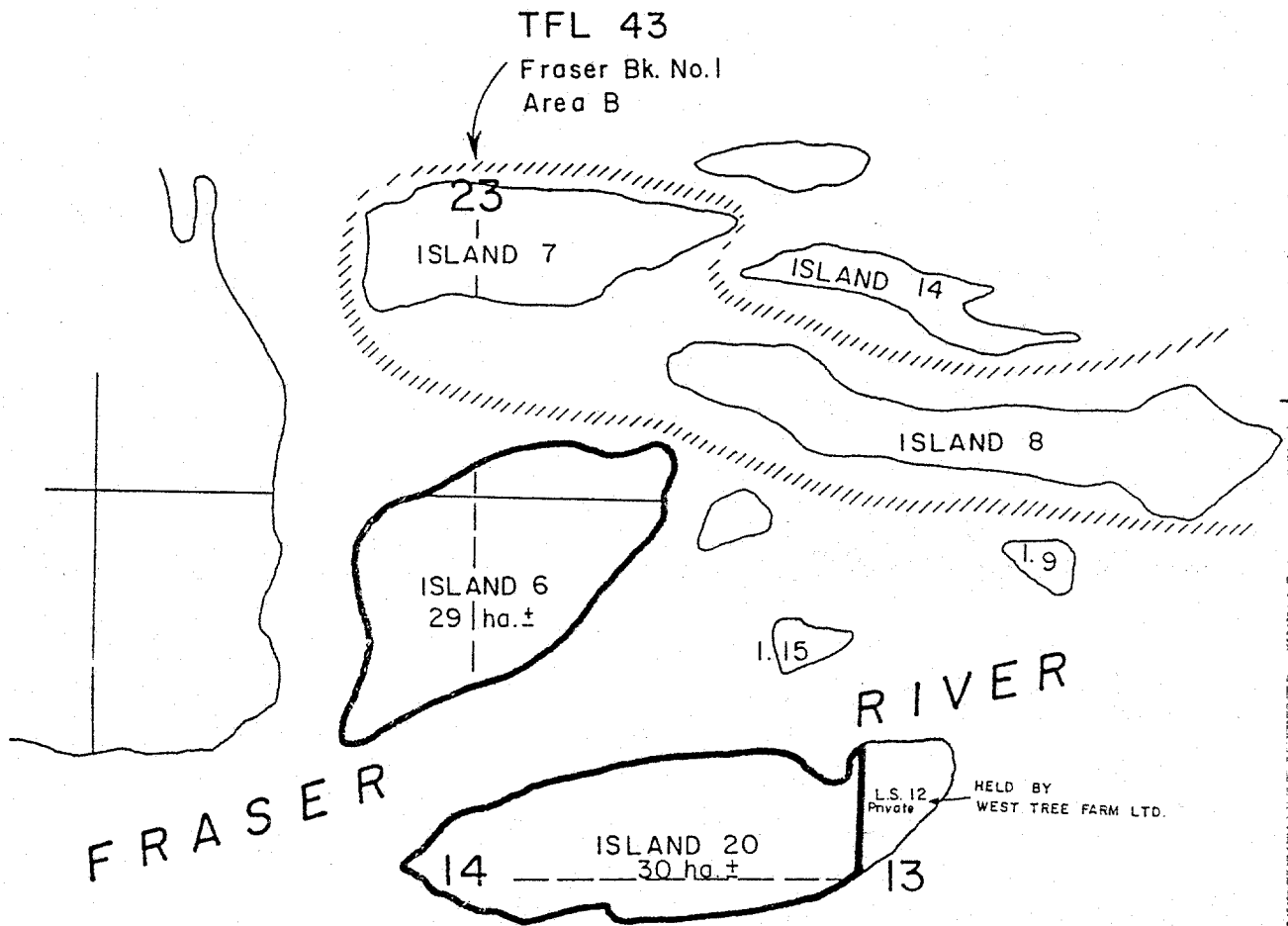
