**WHEREAS:**

- A. Pursuant to the provisions of the *Forest Act*, the Licensor and Licensee entered into a replacement agreement for Tree Farm Licence (TFL) 44, dated August 1, 1999;
- B. The Licensor and the Licensee have mutually agreed to delete certain lands from Schedule "A" of the said TFL, for commercial gravel pit purposes.

**THEREFORE:**

Pursuant to Section 39(1)(e) of the *Forest Act*, the parties agree to delete the following parcel of land from Schedule "A" of TFL 44:

That part of Block 209, Alberni District, except Plan 48620  
(8.4 hectares, more or less) outlined in bold black on the attached plan.

The said land so withdrawn shall henceforth no longer be part of or subject to the said TFL 44.
