WHEREAS:


- A. The Licensee is the holder of Tree Farm Licence 44, dated August 1, 2019.
- B. The Licensee, in a letter dated November 20, 2019, has provided consent pursuant to Section 39.1 of the *Forest Act* to the Minister changing the boundary of TFL 44 by deleting 73.3 ha from the Malachan Block B parcel.

- C. The Minister considers that forest management would not be compromised by the requested amendments.


THEREFORE THE PARTIES AGREE THAT:

1. In accordance with Section 39.1 of the *Forest Act*, Tree Farm Licence 44 is amended, as of the effective date of this instrument, by deleting from the Schedule B lands of the licence area 73.3 ha within the Malachan Block B parcel as delineated on the attached map.
2. There will be no Allowable Annual Cut impact as a result of this deletion.

Ditidaht Land Transfer - Deletion from TFL 44

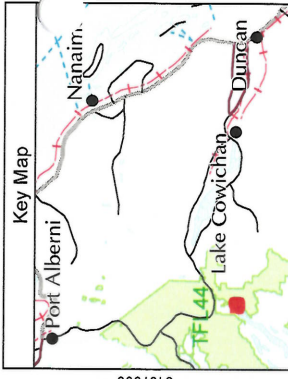
