WHEREAS the lands described hereinafter lies within Tree Farm Licence Number 46, and the said two parcels of land are required for the purpose of a sawmill site;

AND whereas the Licensor is in agreement with the withdrawal of the aforementioned lands from Schedule "A" of the said tree farm licence.

Therefore, pursuant to Section 39(1)(e) of the *Forest Act*, the parties agree to the withdrawal from Schedule "A" of the said Tree Farm Licence Number 46 of the following lands:

1. That part of Parcel A (DD 73809I) of the Southwest 1/4 of Section 6, Township 10, Renfrew District, as shown outlined in red on the plan deposited under DD 102713I.
2. Parcel A (DD 73809I) of the Southwest 1/4 of Section 6, Township 10, Renfrew District, except that part shown outlined in red on the plan deposited under DD 102713I.

The said land so withdrawn shall be henceforth no longer be part of or subject to the said Tree Farm Licence Number 46, but will continue to be subject to the provisions of the *Forest Land Reserve Act*.
