Amendment

THIS AGREEMENT is made effective the 15 day of July, 2009
(the "Effective Date")

BETWEEN:

WHEREAS:

- A. The Licensee is the holder of Tree Farm Licence 46 ("TFL 46");
- B. Pursuant to the *Forestry Revitalization Act*, S.B.C. 2003, c.17 (the "*Forestry Revitalization Act*"), the Minister of Forests and Range issued Orders 3(2) 23-2, 3(2) 23-3, 3(2) 23-4, 3(2) 23-5 and 3(2) 21-3, which, under Section 3(3) of the *Forestry Revitalization Act*, reduced the allowable annual cut ("AAC") attributable to Tree Farm Licence 46 by 118,107 m³, effective December 31, 2004, and an additional 12,530 m³, effective December 31, 2005;
- C. The government wishes to partially offset this reduction under Section 3(3) of the *Forestry Revitalization Act* by deleting Crown land from Tree Farm Licence 46 under Section 39.1 of the *Forest Act*, R.S.B.C. 1996, c.157 (the "*Forest Act*");
- D. The Licensee has consented to this deletion.

THEREFORE the Licensor and the Licensee agree as follows:

1. In accordance with Section 39.1(1) of the *Forest Act*, the boundary and area of Tree Farm Licence 46 is changed by deleting, as of the Effective Date, from Tree Farm Licence 46, Block 1, the Crown land identified as "Reallocation Deletion from Tree Farm Licence 46, Block 1 (Map 4 of 4)" on the map attached as Appendix 1 to this Instrument (the "Deletion").
2. The Deletion:
 - (a) comprises an area of 586 hectares +/-; and
 - (b) offsets the reduction under Section 3(3) of the *Forestry Revitalization Act* in respect of Order #3(2) 23-4 by 4,587 m³/year.

This Instrument has been executed by the Licensor and the Licensee as of the Effective Date.
