Amendment

THIS AGREEMENT is dated the 16th day of July, 1992.

BETWEEN:

Whereas the lands described hereinafter are within
Tree Farm Licence Number 47, and are required for a B.C. Hydro and
Power Authority statutory right of way for the Dunsmuir - Gold River
transmission line.

And whereas the licensee has given his consent to the
withdrawal of the aforementioned lands from Schedule "A" of the said
tree farm licence;

Therefore, pursuant to Section 33.1 of the Forest Act, and
Paragraph 1.04 of the tree farm licence document, the licensor
hereby withdraws the following lands from Schedule "A" of the said
Tree Farm Licence Number 47:

1. That portion of Parcel C (DD71309N), Block 29,
Comox District, Plan 691F, 0.803 hectares.
2. That portion of the North 1/2 of the Northwest 1/4 of
Section 7, Township 6, Comox District, Plan 552E,
1.130 hectares.

3. That portion of the Southeast 1/4 of Section 7, Township 6, Comox District, Plan 552E, except those parts in Plan 204, R/W, 0.510 hectares.
4. That portion of the South 1/2 of the Northwest 1/4 of Section 7, Township 6, Comox District, Plan 552E, 1.360 hectares.
5. That portion of the South 1/2 of the Southwest 1/4 of Section 18, Township 6, Comox District, Plan 552E, 0.002 hectares.
6. That portion of the East 1/2 of the Southwest 1/4 of Section 7, Township 6, Comox District, Plan 552E, except that part in Plan 204, R/W, 0.128 hectares.

Namely, all that tract of land being more particularly shown outlined in bold black on the plan attached hereto and the said lands so withdrawn are and shall be henceforth no longer part of or subject to the said Tree Farm Licence Number 47.

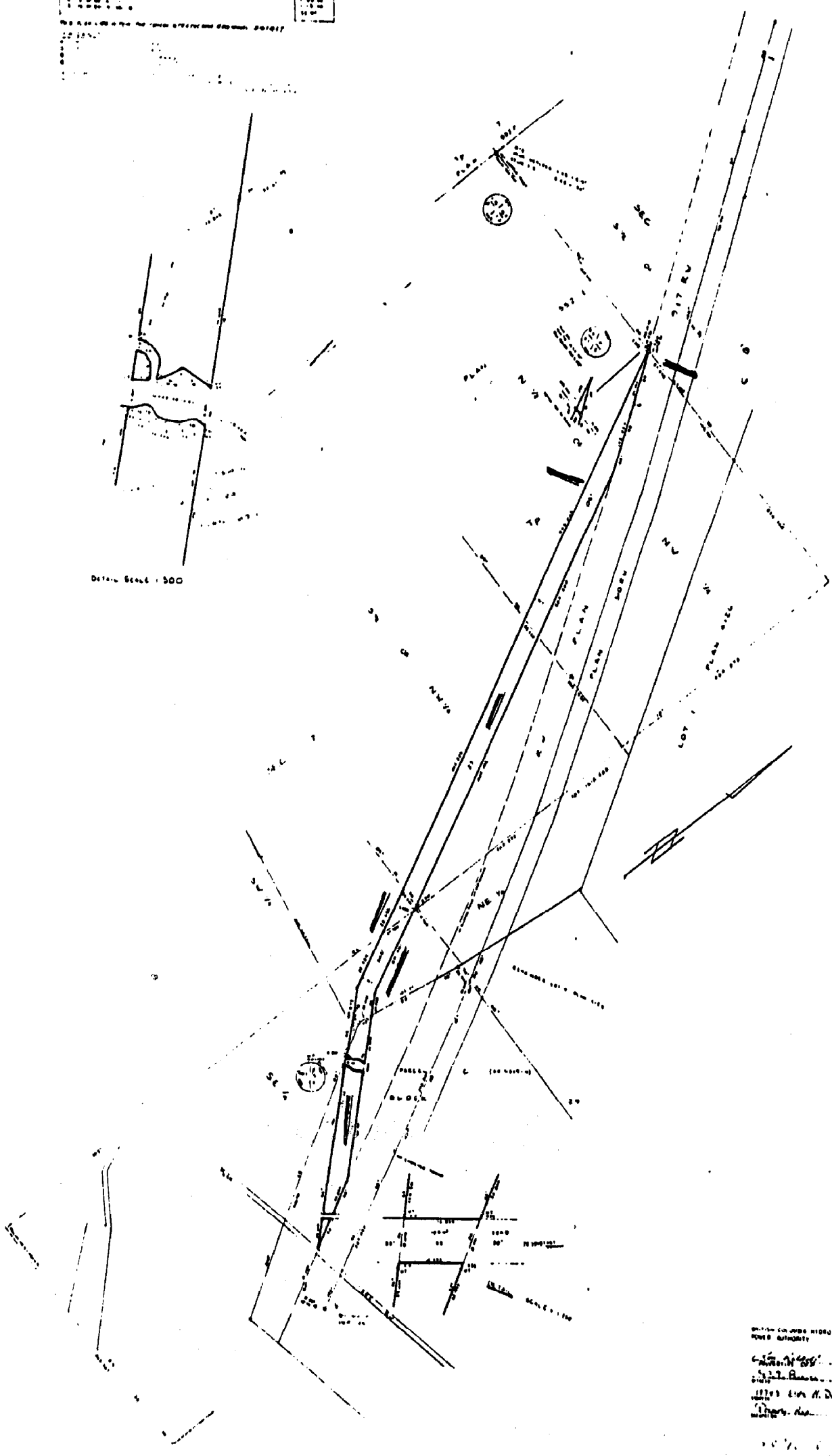
PLAN OF STATUTORY RIGHT OF WAY

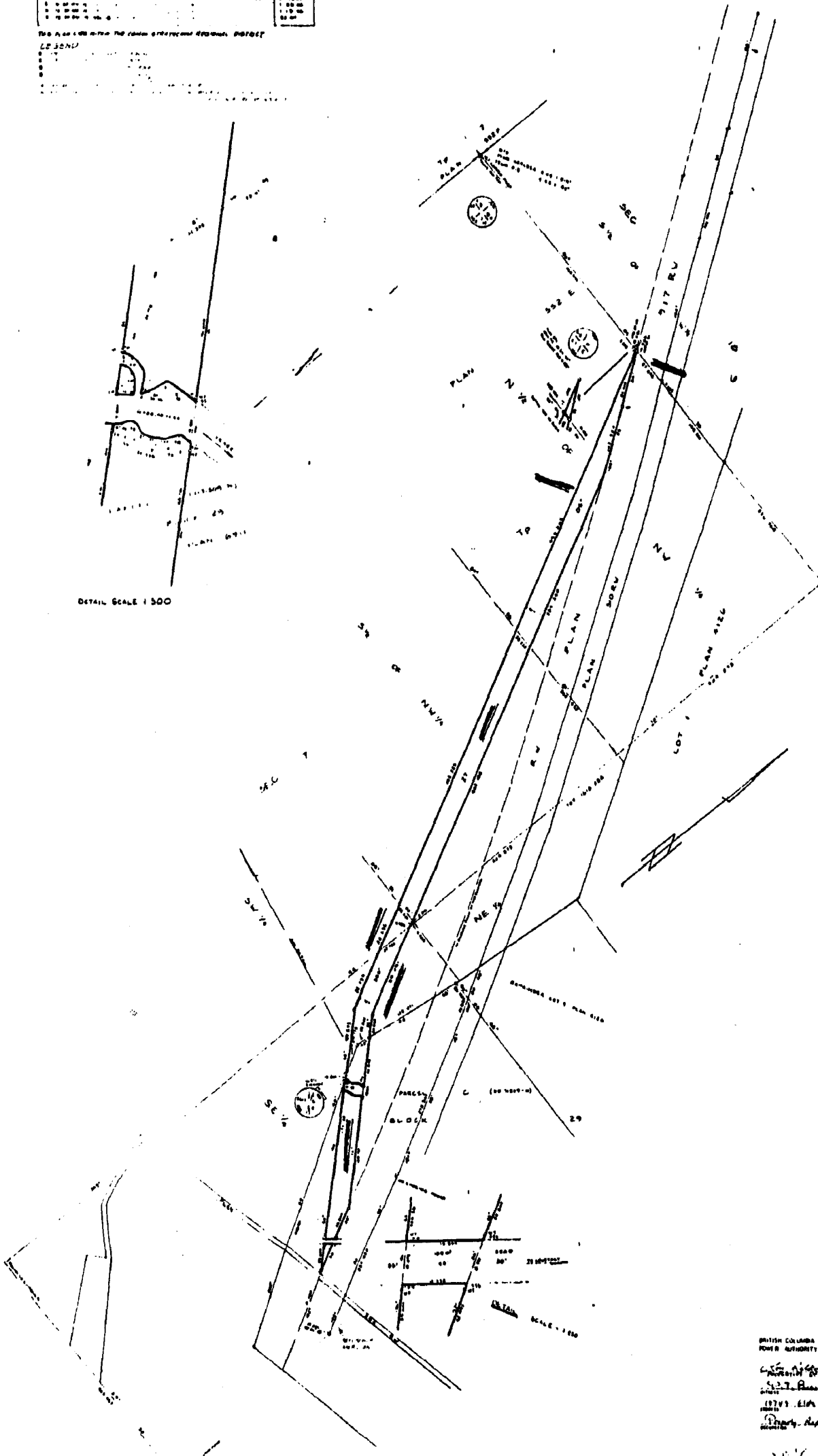



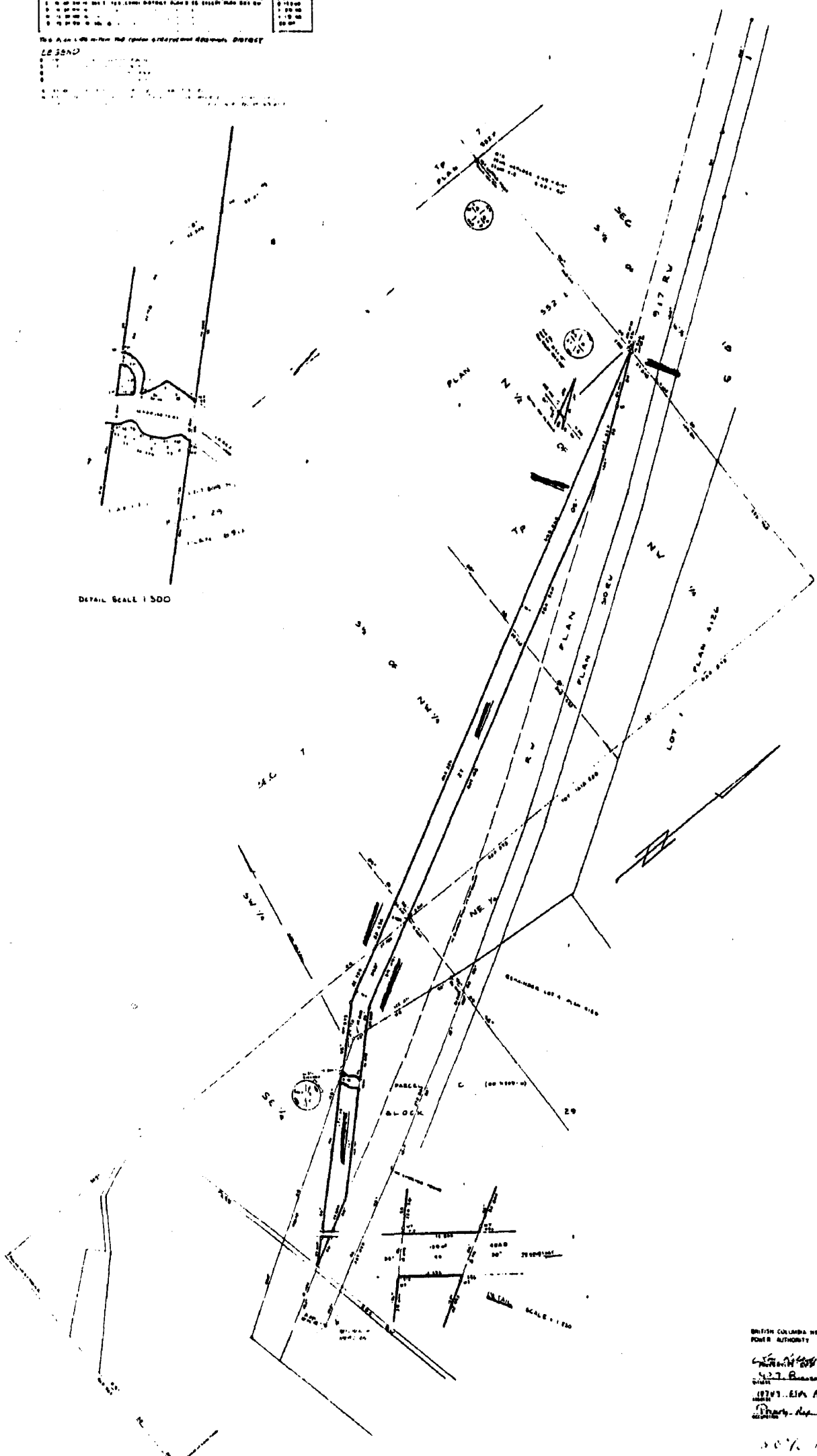
