Whereas the land described hereinafter lies within  
Tree Farm Licence Number 49, and is required for a B.C. Hydro  
electric distribution line right-of-way.

And whereas the Licensor is in agreement with the  
withdrawal of the aforementioned lands from Schedule "A" of the said  
tree farm licence;

Therefore, pursuant to Section 33.1 of the Forest Act, and  
Paragraph 1.04 of the tree farm licence document, the Licensor  
hereby consents to the withdrawal from Schedule "A" of the said  
Tree Farm Licence Number 49 of the following land:

That portion of Lot 3746, Osoyoos Division, Yale District (except that part included in Plan 4110), containing 1.8 hectares, more or less, more particularly shown outlined in bold black on the plan attached hereto.

The said land so withdrawn shall be henceforth no longer part of or subject to the said Tree Farm Licence Number 49.

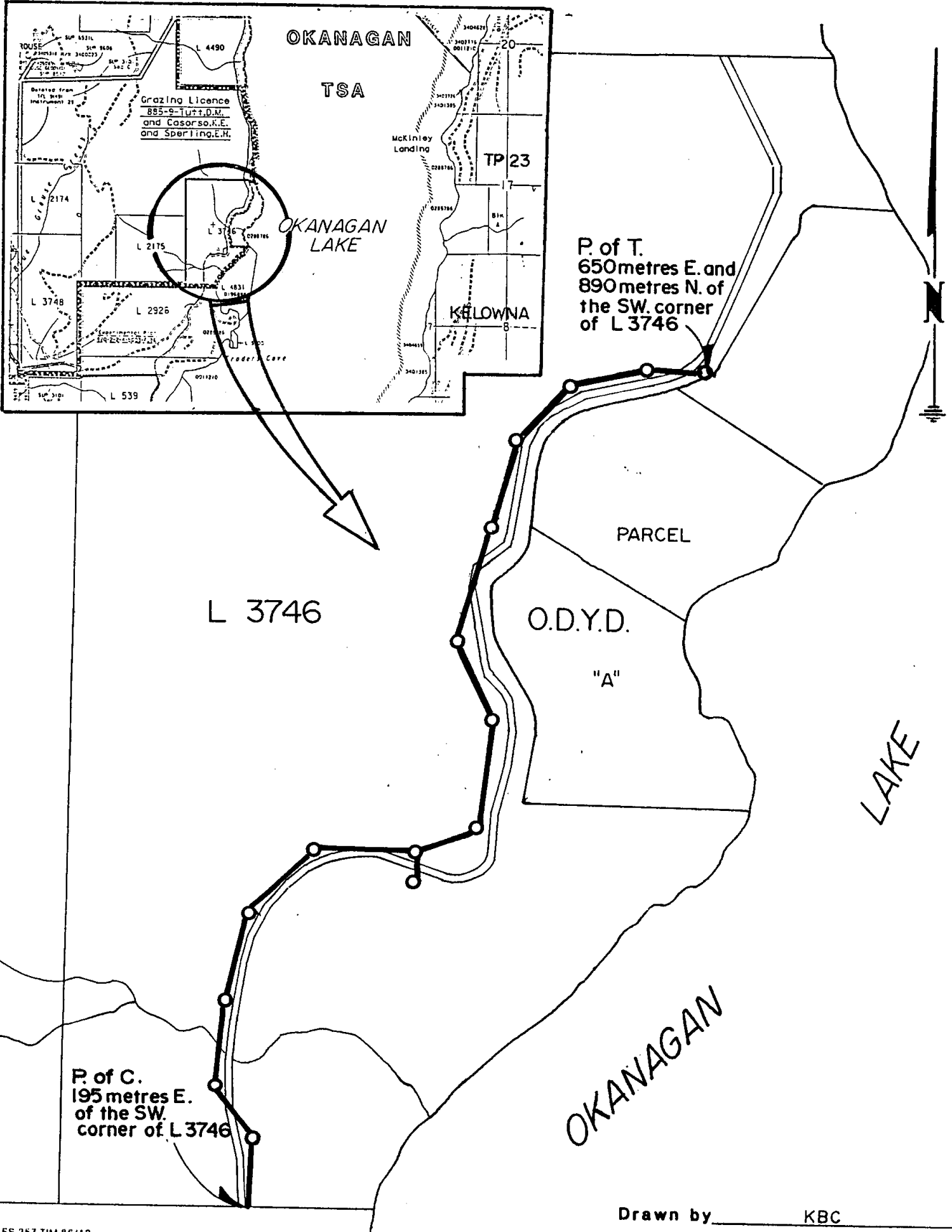
MAP OF **INSTRUMENT NO. 5**
