No. 23 – Digital Download of Mineral, Placer and Coal Title Data

Revision Date: November 4, 2015

DataBC, a data and information gateway, offers many services including the download of digital spatial data from the Distribution Service. The **Distribution Service** allows users to order and **download** data via DataBC from a central repository known as the British Columbia Geographic Warehouse (BCGW). This provincial geographic information stored in the warehouse can provide support for business requirements in natural resource sectors, government agencies, industry and the general public.

Clients wishing to download spatial files (ie. shapefiles) or data tables can log onto this service as a Guest User or using their BCeID. All Mineral Titles datasets (i.e. Titles, Reserve sites and client information for mineral, placer and coal titles) are available to the public, there are no restrictions if using the guest user account.

DataBC provides access to several other datasets and services such as, MINFILE Mineral Database, Mineral Potential, Surveyed Parcels, Parks, Ecological Reserves and Protected Areas, Private Land, BCGS and NTS grids, Forest Administrative Boundaries, Forest Tenure and Wildlife datasets.

Guest user may experience limited access to some datasets in the Distribution Service. Having a BCeID will allow you to have access to multiple online government services and will provide convenience, security, and privacy.
