ORDER OF THE CHIEF GOLD COMMISSIONER

WHEREAS, Eric Konrad Nelson, the recorded holder of mineral claims title numbers 1093600, 1093602, 1093616, 1093618, 1093620, 1093629, 1093812, 1093813, 1093922, 1093923, 1093925, 1093926, 1093927, 1093928, 1093931, 1093933 registered technical exploration and development work pursuant to the mineral claims under Section 29 of the *Mineral Tenure Act* (the Act);

AND WHEREAS, Section 33(1) of the Act requires the recorded holder to submit a report in the form and manner prescribed by the regulations respecting this technical exploration and development;


AND WHEREAS notice was given to the recorded holder of the intention to cancel the registration of the recording of exploration and development if a report in the form and manner prescribed by the regulations was not submitted;

AND WHEREAS the recorded holder has not submitted a report in the form and manner as prescribed by the regulations;

I, Donna Myketa, Chief Gold Commissioner for the Province of British Columbia, order the cancellation of the work credits recorded on event 5975403 based on the following:

- Section 16(4) of the Mineral Tenure Act Regulation (the Regulation) states that a technical report must be submitted within 90 days from the date of registration of work in a format acceptable to the Chief Gold Commissioner.

- Section 16(5) of the Regulation states that if the recorded holder fails to submit a report as required, the Chief Gold Commissioner may notify the recorded holder of the intention to cancel the registration of the recording of exploration and development under Section 33 of the Act.
- On March 02, 2023, exploration and development work was registered and recorded as per Mineral Titles Online event numbers 5975403.
- On June 27, 2023, you were advised by email of an intention to cancel the registration of the recording of the exploration and development work that the report for events 5975403 had not been received.
- To date, the report has not been received.
