ORDER OF THE CHIEF GOLD COMMISSIONER


WHEREAS, Tech-X Resources Inc, the recorded holder of mineral claims title number 1026026, 1028108, 1028109, 1028110, 1028111, 1028113, 1028114, 1028139, 1028140, 1036649, 1036650, 1038255, 1043678, 1043981, 1044903, 1044908, 1045042, 1057511, 1057516, 1059091, 1059379, 1059916, 1060033, 1060442, 1071220, 1073395, 1076780, 1077172, 1078521, 1081446, 1083057, 1083058, registered technical exploration and development work pursuant to the mineral claims under Section 29 of the *Mineral Tenure Act* (the Act);

AND WHEREAS, Section 33(1) of the Act requires the recorded holder to submit a report in the form and manner prescribed by the Mineral Tenure Act Regulation (the Regulation) respecting this technical exploration and development;

I, Donna Myketa, Chief Gold Commissioner for the Province of British Columbia, order the reduction of the work credits recorded on event 5928577 based on the following:

- Section 16(3) of the Regulation requires that the report must be in the form and medium specified in Schedule A of the Regulation.

- Section 16(5) of the Regulation states that if the recorded holder fails to submit a report, as required under section 16(3) of the Regulation, the Chief Gold Commissioner may notify the recorded holder of the intention to cancel the registration of the recording of exploration and development under Section 33 of the Act.
- On March 18, 2022, exploration and development work was registered and recorded as per Mineral Titles Online event number 5928577.
- On April 25, 2022, a technical report was submitted under Mineral Titles Online event number 5928577 for the total applied work value of \$193,533.00.
- On August 23, 2023, you were advised by email of an intention to reduce the registration of the recording of the exploration and development work that the submitted report for event 5928577 was approved at a value of \$81,333.63 instead of \$193,533.00.
- For these reasons, the value of work applied to mineral claims 1083057, 1083058 is reduced by \$77,433.34.
