The Lieutenant-Governor in Council:

Res No 2325/58

The undersigned has the honour to recommend that pursuant to Sub-section (5) of Section 14 of the "Mineral Act" and Sub-section (1) of Section 16 of the "Placer-mining Act", Chapters 213 and 214 of the "Revised Statutes of British Columbia" 1948, respectively, a reserve be placed on all minerals in an area of the Kamloops Mining Division defined as follows:

All that part of the bed of the Thompson River lying between the following lines:

- a) from the centre point of the mouth of Cornwall Creek at its confluence with the said Thompson River a line shall be drawn at right angles to the flow of the said Thompson River at that point and extended in both directions.
- b) from the centre point of the mouth of Barnes Creek at its confluence with the said Thompson River a line shall be drawn at right angles to the flow of the said Thompson River at that point and extended in both directions.
- c) and in addition thereto an area of land 100 yards on either side of the said part of the bed of the said Thompson River.

AND TO RECOMMEND THAT the said reserve on "mineral" as defined in the "Placer-mining Act" be cancelled subject to the following provision:

That the Ashcroft Centennial Committee have the right to conduct a competition for panning placer gold within the lands described above.

AND THAT this Order shall be effective until the first day of October 1958 but not thereafter.

AND THAT the undersigned Minister of Mines do sign an Order to that effect.
