The Lieutenant-Governor in Council:

The undersigned has the honour to recommend that, pursuant to subsection (5) of Section 12 of the "Mineral Act", Chapter 244, Revised Statutes of British Columbia, 1960, as amended by Chapter 39, Statutes of British Columbia, 1961, and Chapter 39, Statutes of British Columbia, 1962, and Section 11 of the "Placer-Mining Act", Chapter 285, Revised Statutes of British Columbia, 1960, no person may locate or mine upon the following described area in the Osoyoos Mining Division for any mineral therein:-

Commencing at the Southeast corner of Lot 259, Similkameen (formerly Osoyoos) Division of Yale Land District; thence Northerly and Westerly along the Easterly and Northerly boundaries of said Lot 259 to the Southeast corner of Lot 2076^s; thence Northerly along the Easterly boundary of Lot 2076 to the Northeast corner thereof; thence Northerly along the Westerly boundaries of Lots 302 and 301 and the Easterly boundaries of Lots 698^s and 2092^s to the Northeast corner of said Lot 2092^s; thence Westerly along the Northerly boundary of said Lot 2092^s to the Southwest corner of Lot 1697^s; thence Northerly and Easterly along the Westerly and Northerly boundaries of said Lot 1697^s to the Northeast corner thereof; thence Northerly along the Westerly boundary of Lot 2450^s to the Southeast corner of Section 2, Township 54; thence due West in a straight line to the southerly prolongation of the Westerly boundary of Lot 667^s; thence Northerly along the said Southerly prolongation of the Westerly boundary of Lot 667^s to the Southwest corner thereof; thence Westerly, Northerly and Easterly along the Southerly, Westerly and Northerly boundaries of Lot 668^s to the most Southerly Southwest corner of Lot 2063; thence Northerly, Westerly and Northerly along the boundaries of said Lot 2063 to the Northwest corner thereof; thence Westerly and Northerly along the Southerly and Westerly boundaries of Lot 27^s to the Northwest corner thereof; thence Westerly and Northerly along the Southerly and Westerly boundaries of Lot 19^s to the Easterly prolongation of the Southerly boundary of Lot 287; thence Westerly along the said Easterly prolongation of the Southerly boundary of Lot 287 to the Southeast corner thereof; thence Westerly along the Southerly boundaries of Lots 287 and 288 to the Northwest corner of Lot 670^s; thence Southerly along the Westerly boundaries of Lots 670^s, 3122^s, 3121^s, 2120^s and 2119^s to the Southwest corner of said Lot 2119^s; thence Westerly along the Northerly boundaries of Lots 2117^s, 2893^s, and 2898^s to the Northeast corner of Lot 243; thence Southerly along the Easterly boundaries of Lots 243 and 244 to the Southeast corner of said Lot 244; thence Easterly and

Southerly along the Northerly and Easterly boundaries of Indian Reserve #3, Indian Reserve #5, Lot 1^s, and Lot 468 to the Southeast corner of said Lot 468; thence due South to the Westerly prolongation of the Southerly boundary of Lot 2100^s; thence Easterly along the said Westerly prolongation of the Southerly boundary of Lot 2100^s to the Southwest corner thereof; thence Easterly along the Southerly boundaries of Lots 2100^s, 1502^s and 1515^s to the Southeast corner of Lot 1515^s; thence Easterly in a straight line to the Southwest corner of Lot 261; thence Easterly along the Southerly boundaries of Lots 261, 260 and 259 to the aforesaid Southeast corner of Lot 259, being the point of commencement.
