
AMM O/C 1643/75

THAT pursuant to the Mineral and Placer-mining Acts and all other powers thereunto enabling, no person may locate or mine in or upon the following areas in the Cassiar Land District, Skeena Mining Division:


Commencing at the intersection of the highwater mark on the left bank of the Nass River with the easterly boundary of the Kitwilluchsilt Indian Reserve No. 7; thence southerly along the said easterly boundary of the Kitwilluchsilt Indian Reserve #7 to the northeast corner of Lot 1093; thence southerly and westerly along the easterly and southerly boundaries of said Lot 1093 to a point 20 chains perpendicularly distant and westerly from the westerly limit of the Aiyansh lava flow; thence in a general southerly and easterly direction parallel to and 20 chains perpendicularly distant westerly and southerly from the westerly and southerly limits of the said Aiyansh lava flow to a point due south of the crater that was the source of the Aiyansh lava flow; thence due east 1 mile; thence due north 1½ miles; thence due west 1½ miles; thence due south to a point 20 chains perpendicularly northerly from the northerly limit of the Aiyansh lava flow; thence in a general westerly direction parallel to and 20 chains perpendicularly distant northerly from the northerly limit of the Aiyansh lava flow to a point on the highwater mark of the left bank of the Tseax River; said point being on the easterly boundary of Lot 4827; thence north-westerly along the said highwater mark of the Tseax River to its intersection with the highwater mark on the left bank of the Nass River; thence southwesterly along the said highwater mark of the Nass River to the easterly boundary of the Kitwilluchsilt Indian Reserve No. 7, being the point of commencement; save and except thereout lands covered by the Snafu Group of mineral claims and Indian Reserves Nos. 61, 5, 6, 46 and 47.

AND TO FURTHER RECOMMEND THAT on and after the expiry of any mineral claim, placer-mining claim or lease the location of which lies within those lands, no person may locate or mine in or upon any area comprised in the location and that this order come into operation with respect to each such location upon such expiry.
