THAT pursuant to the Mineral and Placer-mining Acts and all other powers thereto enabling, no person may locate or mine in or upon the following described lands in the Nanaimo Mining Division, Sayward Land District:

Commencing at a point 6 chains due east of the most westerly northwest tip of John Hart Lake; thence due east 20 chains; thence due south 20 chains; thence due west 20 chains; thence due north 20 chains more or less to the aforesaid point of commencement;

and

That part of Lot 56 more particularly described as follows: Commencing at a point 360 chains due south and 235 chains due east of the most northerly northeast corner of Lot 146, thence due north 15 chains; thence due east 35 chains; thence due south 35 chains; thence due west 35 chains; thence due north 20 chains more or less to the aforesaid point of commencement;

and

That part of Lot 100 more particularly described as follows: Commencing at a point on the easterly boundary of Lot 100, said point being 15 chains south of the northeast corner of said Lot 100; thence due west 45 chains; thence due south 30 chains; thence due east 45 chains more or less to the aforesaid easterly boundary of Lot 100; thence northerly along the said easterly boundary of Lot 100 to the aforesaid point of commencement.

and

These portions of Lot 110 more particularly described as follows: Commencing at a point 30 chains due west and 32 chains due south of the intersection of an unnamed creek and Boot Lake, said unnamed creek flowing southwesterly from Boot Lake into Lawson Lake; thence due west 35 chains; thence due south 25 chains; thence due east 35 chains; thence due north 25 chains more or less to the aforesaid point of commencement; and

commencing at a point on the natural boundary of Merrill Lake on the westerly shore thereof, said point lying 153 chains due west and 19 chains more or less due north of the most southerly corner of Block 8 of Lot 145; thence due west 20 chains; thence due south 25 chains; thence due east 40 chains; thence due north 13 chains more or less to the aforesaid natural boundary of Merrill Lake on the westerly shore thereof; thence in a general northwesterly direction along the said natural boundary of Merrill Lake on the westerly shore thereof to the aforesaid point of commencement:

AND TO FURTHER RECOMMEND THAT on and after the expiry of any mineral claim, placer-mining claim or lease the location of which lies within these lands, no person may locate or mine in or upon any area comprised in the location and that this Order come into operation with respect to each such location upon such expiry.
