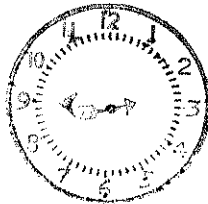

THAT pursuant to the Mineral and Placer-mining Acts and all other powers thereunto enabling, no person may locate or mine in or upon the following described lands in the Alberni and Victoria Mining Divisions:

All that parcel or tract of land together with all that foreshore or land covered by water, situated in Renfrew Land District, more particularly described as follows:

Commencing at the southwest corner of Indian Reserve 9, being a point on the natural boundary of Nitinat Lake, on the easterly shore thereof; thence easterly along the southerly boundary of said Indian Reserve 9 to the southeast corner thereof; thence due south to a point due west of the northwest corner of Block A of Lot 756; thence due east to the said northwest corner of Block A of Lot 756; thence easterly along the northerly boundary of said Block A of Lot 756 to the northeast corner thereof; thence southerly along the easterly boundaries of Blocks A and B of Lot 756 to the southeast corner of said Block B of Lot 756; thence due south 3,960 feet; thence westerly in a straight line to a point on the easterly boundary of Lot 524, said point being 2,640 feet northerly from the southeast corner thereof; thence southerly and westerly along the easterly and southerly boundaries of said Lot 524 to the southwest corner thereof; thence southerly along the easterly boundaries of Lots 59 and 56 to the southeast corner of said Lot 56; thence southeasterly in a straight line to the northeast corner of Lot 50; thence southeasterly in a straight line to the northeast corner of Lot 727; thence southerly along the easterly boundary of Lot 727 to the southeast corner thereof; thence easterly along the northerly boundary of Indian Reserve 6 to the northeast corner thereof; thence easterly and southerly along the northerly and easterly boundaries of Lot 730 to the southeast corner thereof; thence southeasterly in a straight line to the most northerly northeast corner of Lot 732; thence southerly, easterly, southerly and easterly along the easterly, northerly, easterly and northerly boundaries of said Lot 732, to the most easterly northeast corner thereof; thence easterly and southerly along the northerly and easterly boundaries of Lot 734 to the most easterly southeast corner thereof; thence easterly along the northerly boundaries of

Lots 49 and 75 to the northeast corner of said Lot 736; thence southerly along the easterly boundary of said Lot 736 to the northwest corner of Lot 737; thence easterly along the northerly boundary of Lot 737 to the northeast corner thereof; thence southeasterly in a straight line to a point 6,600 feet due west of the northwest corner of Lot 157; thence northeasterly in a straight line to the northwest corner of Lot 707; thence easterly along the northerly boundary of Lot 707 and the southerly boundary of Lot 708; thence northerly along the easterly boundary of said Lot 708 to the northeast corner thereof; thence easterly in a straight line to the southwest corner of Section 11, Township 11; thence northerly and easterly along the westerly and northerly boundaries of Section 11, Township 11 to a point on the said northerly boundary thereof, said point being 660 feet westerly from the northeast corner thereof; thence due south to the natural boundary of Gordon River, on the right bank thereof; thence in a generally easterly, southerly and westerly direction along the said natural boundary of Gordon River to the easterly boundary of Lot 889; thence southerly and westerly along the easterly and southerly boundaries of said Lot 889 to the natural boundary of San Juan River on the right bank thereof; thence in a generally southerly and westerly direction along the said natural boundary of the San Juan River to the northeast corner of Section 2, Township 11; thence due south to a point 2,640 feet perpendicularly distant southeasterly from the natural boundary of Port San Juan on the northerly shore thereof; thence in a generally southerly, westerly and northerly direction along a line drawn parallel to and perpendicularly distant 2,640 feet from the natural boundary of Port San Juan and Juan de Fuca Strait to a point due south of the southwest corner of Indian Reserve 3; thence due north to the natural boundary of Nitinat Narrows being the easterly shore thereof; thence in a generally northerly and easterly direction along the natural boundary of Nitinat Narrows and Nitinat Lake to the aforesaid southwest corner of Indian Reserve 9, being the point of commencement.

All that parcel or tract of land together with all that foreshore or land covered by water situated in Barclay Land District, more particularly described as follows:

Commencing at the northeast corner of Indian Reserve 8, being a point on the natural boundary of Nitinat Lake on the westerly shore thereof; thence northwesterly in a straight line to a point, said point being 1,320 feet due west and 1,980 feet due north of the northwest corner of Indian Reserve 8; thence due north 4,620 feet; thence due west to the southeasterly boundary of the watershed of the Klanawa River; thence in a generally southwesterly direction along the said southeasterly boundary of the watershed of the Klanawa River to the northerly boundary of Lot 527; thence westerly along the said northerly boundary to the northwest corner thereof; thence westerly in a straight line to the most westerly northwest corner of Lot 59; thence westerly along the northerly boundary of Lot 60 to the northwest corner thereof; thence westerly, northerly and westerly along the northerly, easterly and northerly boundaries of Lot 103 to the northeast corner thereof; thence westerly in a straight line to a point on the easterly boundary of Lot 288 said point being 1,320 feet northerly from the southeast corner thereof; thence northerly and westerly along the easterly and northerly boundaries of Lot 288 to the northwest corner thereof; thence northerly and westerly along the easterly and northerly boundaries of Lot 284 to the northwest corner thereof; thence westerly along the northerly boundaries of Lots 282, 281 and 280 to the northwest corner of said Lot 280; thence northerly along the easterly boundaries of Lots 276 and 275 to the northeast corner of said Lot 275; thence westerly along the northerly boundary of Lot 275 to the southeast corner of Lot 277; thence northerly along the easterly boundary of Lot 277 to the northeast corner thereof; thence easterly and northerly along the southerly and easterly boundaries of Lot 662 to the northeast corner thereof; thence northerly along the easterly boundary of Lot 659 to the northeast corner thereof; thence easterly

and northerly along the southerly and easterly boundaries of Lot 656 to the northeast corner thereof; thence northerly along the easterly boundaries of the Fractional west halves of Sections 4 and 9, Township 1, to the northeast corner of the said Fractional west half of Section 9; thence westerly in a straight line to the northeast corner of Indian Reserve 12; thence westerly along the northerly boundary of said Indian Reserve 12 to the northwest corner thereof; thence northerly in a straight line to the northeast corner of the south half of the northwest quarter of Section 17, Township 1; thence westerly in a straight line to a point on the westerly boundary of Section 17, Township 1, said point being 1,320 feet northerly of the southwest corner of the northwest quarter of said Section 17, Township 1; thence northerly along the said westerly boundary of Section 17, Township 1, to the natural boundary of Bamfield Inlet; thence in a generally southwesterly direction along the said natural boundary of Bamfield Inlet to the easterly boundary of Indian Reserve 9; thence southerly and westerly along the easterly and southerly boundaries of said Indian Reserve 9, to the natural boundary of Trevor Channel; thence due west 10,560 feet; thence due south 10,560 feet; thence southeasterly in a straight line to a point due south of the southwest corner of Lot 280, said point being perpendicularly distant 2,640 feet southwesterly from the natural boundary of the Pacific Ocean; thence in a generally southerly and easterly direction along a line drawn parallel to and perpendicularly distant 2,640 feet from the natural boundary of the Pacific Ocean and Juan de Fuca Strait to a point due south of the southwest corner of Lot 71; thence due north to the natural boundary of the Pacific Ocean; thence in a generally southerly, easterly, northerly and easterly direction along the natural boundary of the Pacific Ocean, Nitinat Harrows and Nitinat Lake to the aforesaid northeast corner of Indian Reserve 8, being the point of commencement.

AND TO FURTHER RECOMMEND THAT on and after the expiry of any mineral claim, placer-mining claim or lease the location of which lies within these lands, no person may locate or mine in or upon any area comprised in the location and that this Order come into operation with respect to each such location upon such expiry.
