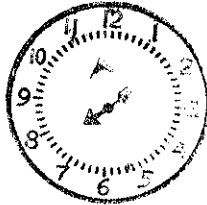

THAT pursuant to the Mineral and Placer-mining Acts and all other powers thereunto enabling, no person may locate or mine in or upon the following described lands in the Vancouver Mining Division, New Westminster Land District:

All that parcel or tract of land together with all that foreshore or land covered by water situated in Group 1, New Westminster District, more particularly described as follows:

Commencing at the northeast corner of Lot 4186, Group 1, New Westminster District, being a point on the high water mark of Monfray Channel on the southeasterly shore thereof; thence southerly along the easterly boundary of Lot 4186 to the southeast corner thereof; thence due south to the northerly boundary of the watershed of Unwin Lake; thence easterly and southerly along the northerly and easterly boundaries of the watershed of Unwin Lake to the northwesterly boundary of the watershed of Theodosia River; thence southwesterly along the north-westerly boundaries of the watersheds of Theodosia River and Theodosia Inlet to a point due north of the northeast corner of Lot 4926; thence south to said corner and continuing southerly along the easterly boundary of Lot 4926 to the southeast corner thereof; thence easterly and southerly along the northerly and easterly boundaries of said Lot 4926 to the southeast corner thereof; thence North 80° West a distance of 1.0 miles; thence South 05° West a distance of 2.0 miles; thence South 60° West a distance of 1.0 miles; thence North 62° West a distance of 1.25 miles; thence due west to a point due North of the most easterly northeast corner of Lot 1476; thence due South to said northeast corner; thence southerly, westerly, northerly and easterly along the easterly, southerly, westerly, and northerly boundaries of said Lot 1476 to the most

northwesterly northeast corner thereof; thence due North a distance of 0.50 miles; thence North 40° West a distance of 2.0 miles; thence due North a distance of 0.5 miles; thence due East a distance of 1.5 miles; thence North 60° East a distance of 3.0 miles; thence North 40° West a distance of 2.0 miles; thence North 20° East a distance of 1.75 miles; thence northeasterly in a straight line a distance of 4.1 miles, more or less, to a point 0.25 miles due North of the point of commencement; thence south to the point of commencement, save and except Indian Reserve No. 6.

AND TO FURTHER RECOMMEND THAT on and after the expiry of any mineral claim, placer-mining claim or lease the location of which lies within those lands, no person may locate or mine in or upon any area comprised in the location, and that this Order come into operation with respect to each such location upon such expiry.
