EXECUTIVE COUNCIL CHAMBERS, VICTORIA -4. OCT. 1973

[Signature] Pursuant to the Mineral and Placer-mining Act and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

(1) No person may locate or mine in or upon the following described lands in the Vancouver Mining Division, Range 1, Coast Land District:

Area A - Commencing at a point 2.5 chains north and 16 chains west of the most southerly southwest corner of T.L. 10838P; thence due south 1 chain; thence due west 31 chains; thence due north 17 chains; thence due east 23 chains; thence due south 11 chains more or less to a point North 60 degrees West of the aforesaid point of commencement; thence South 60 degrees East 9.5 chains more or less to said point of commencement;

Area B - Commencing at a point on the northerly boundary of T.L. 10837P, said point being 7 chains west of the most northerly northeast corner of said T.L. 10837P; thence due north 10 chains; thence due east 10 chains; thence due south 15 chains; thence due west 10 chains more or less to a point due south of the aforesaid point of commencement; thence north 5 chains more or less to said point of commencement.

and

(2) On and after the expiry of any mineral claim, placer-mining claim or lease the location of which lies within these lands, no person may locate or mine in or upon any area comprised in the location, and that this Order comes into operation with respect to each such location upon expiry.
