Pursuant to the Mineral Act and Placer-mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- (1) No person may locate or mine in or upon the following described lands in the Cariboo Mining Division, Cariboo Land District:

All that parcel or tract of land situated in the vicinity of Horsefly Lake, Cariboo Land District, more particularly described as follows:

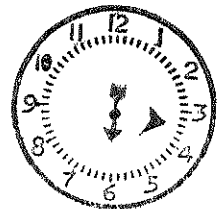
Commencing at the most northerly northwest corner of Lot 11484; thence due south to a point on the southerly limit of Public Road, said point being approximately 6 chains due east and 10 chains due north of the northeast corner of Lot 11575; thence in a generally southwesterly direction along the said southerly limit of Public Road to the northerly boundary of Lot 11571; thence easterly along the said northerly boundary of Lot 11571 to the northwest corner of Lot 11575; thence easterly and southerly along the northerly and easterly boundaries of said Lot 11575 to the natural boundary of Horsefly Lake, on the northerly shore thereof; thence in a generally northeasterly direction along the said natural boundary of Horsefly Lake to the southwest corner of Lot 11897; thence northerly along the westerly boundary of said Lot 11897 to the northwest corner thereof; thence due west to the natural boundary of Dillabough Creek on the right bank thereof; thence in a generally southwesterly direction along the said right bank of Dillabough Creek to the northerly boundary of Lot 11484; thence westerly along the said northerly boundary of Lot 11484 to the afore-said most northerly northwest corner thereof, being the point of commencement.
