EXECUTIVE COUNCIL CHAMBERS, VICTORIA 23. APR. 1974

RR

Pursuant to the Mineral Act and Placer-mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- (1) No person may locate a mineral claim, placer-mining claim or placer-mining lease in or upon the following described lands in the Nanaimo Mining Division, Rupert Land District, in the period commencing on the date of approval of this order and terminating December 31, 1975:

Commencing at the northeast corner of Timber Licence 11924^P, being the northwest corner of Block 3 of Tree Farm Licence 25; thence southerly along the westerly boundary of said Block 3 to the most westerly northwest corner of Timber Licence 8942^P; thence due east to the easterly boundary of the watershed of Tsitlika River; thence generally southerly, westerly and northerly around the watershed boundary of Tsitlika River to the southerly shore of Johnstone Strait; thence easterly along the natural boundary of said shoreline to the northeast corner of Timber Licence 11924^P, being the point of commencement.

and

- (2) On and after the expiry of any existing mineral claim, placer-mining claim or lease the location of which lies within these lands, no person may locate or mine in or upon any area comprised in the location during the aforementioned period, and that this Order comes into operation with respect to each such location upon expiry.

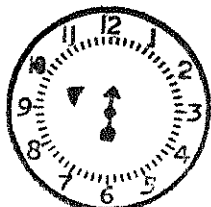
