EXECUTIVE COUNCIL CHAMBERS, VICTORIA 14 NOV 1974

Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- (1) No person shall locate or mine upon the following described lands in the New Westminster Mining Division, Yale Division of Yale Land District:

Commencing at a point 45 chains due east and 50 chains due south of the northwest corner of Section 1, Township 2, Range 28, West of the 6th Meridian; thence due east 20 chains; thence South 55 degrees East 19 chains more or less to the easterly boundary of said Section 1; thence southerly along the said easterly boundary of Section 1 to the natural boundary of Chilliwack River on the right bank thereof; thence North 58 degrees West 23 chains more or less to the said natural boundary of Chilliwack River on the right bank thereof; thence in a general westerly direction along the said natural boundary of Chilliwack River on the right bank thereof to a point thereon due south of the aforesaid point of commencement; thence north 7 chains more or less to said point of commencement.

and

- (2) On and after the expiry of any existing mineral claim, placer-mining claim or lease the location of which lies within these lands, no person may locate or mine in or upon any area comprised in the location, and that this Order comes into operation with respect to each such location upon expiry.

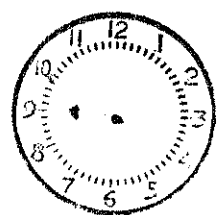
